standing in the name or names of or belonging to any other person or
persons.
AND ALSO after such PURCHASE and TRANSFER to receive all INTEREST
and DIVIDENDS to accrue due on all or any of such last mentioned
STOCKS, FUNDS and SECURITIES.
AND ALSO for me and in my name and on my behalf to ask, demand, sue
or recover and receive of and from all and every or any person or
persons, JOINT STOCK or OTHER COMPANY or CORPORATION whomsoever and
Whatsoever, all and every sum and sums of MONEY, DEBTS, WAGES, DUES, GOODS,
SHARES and any OTHER PROPERTY, EFFECTS and THINGS whatsoever which now

AND ALSO to MAKE, SIGN, SEAL and DELIVER any CONTRACT, AGREEMENT, TRANSFER, CONVEYANCES, BILLS OF SALE or any OTHER DEEDS.
