The Secretary of the Board may, on the request of an elector prior to the Friday preceding Commencement Day, furnish by mail or in person an official ballot to such elector to be voted by mail in place of a ballot which has been lost or not received by the

elector or which has been spoiled or defaced.

In all other respects, except as herein expressly modified, elections of Overseers shall, until the adoption of other rules and regulations, be conducted in accordance with the statutory provisions and Rules and Regulations heretofore in force regulating such elections.

#### DUTIES OF A MEMBER OF THE BOARD OF OVERSEERS

The meetings of the Board of Overseers consist usually of eight stated and one or two special meetings distributed through

academic year from September to June.

Each member is expected to serve on Standing Committees or

Visiting Committees to which appointments are made by the Board upon the nomination of the Executive Committee. In practice, the number of committees to which each member is assigned

varies from one to four.

The ordinary business of the Board consists, first, of the receipt of formal communications from the President and Fellows, comprising (1) appointments to all teaching positions for a term longer than one year, and to the more important administrative offices and boards; (2) all degrees — both ordinary and honorary; (3) changes in the statutes of the University; (4) other important orders and regulations. All these matters are submitted by the President and Fellows to the Board of Overseers, "that they may consent thereto if they see fit."

In the second place, the Board receives from the President informal communications for the information of the Board, or for

the purpose of obtaining their counsel.

In the third place, the Board discusses, on the initiative of its own members or committees, affairs relating to the University and its several Departments and questions are addressed to the President in regard to any matters on which information is desired

from him.

The Visiting Committees, of which Overseers are usually chairmen, are the instrumentality through which the Overseers keep themselves informed of what work the University is doing and of the way in which that work is done. It is partly through these committees, which usually include in their membership a majority who are not members of the Board, that the University of in touch with the outer world; and it is also through them legitimate interest of the public in the conduct of the University can be most effectively expressed for purposes of criticism, suggestion, coöperation, and support. The work of the committees is done by individual visiting of classrooms, libraries, museums, laboratories, etc., by consultation with teachers and administrative officers, and by meetings of the committees. The chairman of each committee is expected to make occasional informal or oral reports to the Board and to make a report in writing at least once

Naturally, the exigencies of business and public office and remoteness of residence are factors limiting the time which Overseers can give to their duties if elected and are to be taken into account in determining a candidate's availability for this service. The advantages to the University, however, of having a representation on the Board from the more remote parts of the country have been held to compensate for the disadvantages of infrequent or uncertain attendance. On the other hand, it is important that a substantial proportion of the membership of the Board should be counted on for regular attendance at Board and committee

meetings.

#### OF HARVARD COLLEGE

In accordance with a vote of the Directors of The Harvard Alumni Association, and with the approval of the Board of Overseers, the standing Committee for Nomination of Overseers has been instructed to nominate this year candidates to a number at least twice and not more than four times the number of vacancies

The Committee, in pursuance of a vote of the Directors of the Alumni Association, suggests for election no person whose six-year term of office as Overseer has expired within one year of such election. The names of the fifteen candidates nominated by the Committee appear upon the official ballot in the chronological order of the first academic degrees received by them.

By the provisions of the Statutes of the Commonwealth of shusetts, supplemented by the joint action of the Corporation I the Overseers, holders of the degree of Master of Arts, and of Honorary Degrees, are entitled to vote for Overseers immediately upon receiving their degrees; holders of all other degrees are entitled to vote for Overseers at the fifth annual election after they have received their degrees.

No member of the Corporation and no officer of instruction or

government in the University, except a Professor Emeritus, is eligible as an Overseer or entitled to vote in the election of Overseers.

The Committee invited suggestions from one hundred and thirty-one Harvard Clubs, forty-four classes, six professional school alumni associations, and two hundred and three prominent graduates. One hundred and ninety-seven names were suggested and carefully considered.

#### RULES GOVERNING THE ELECTION OF OVERSEERS

The Secretary of the Board of Overseers shall, on or before the fifteenth day of April in each year, mail to each of the persons entitled to vote in the election of Overseers of that year, at the address of such person as it appears on the records of the office of the Harvard Alumni Directory, or such other office as from time to time hereafter may be designated by the Board of Overseers, an official ballot for the election of Overseers. Such ballot shall have upon it a space for the signature of the elector desiring to vote and such directions concerning its use as the Secretary of the Board of Overseers shall from time to time determine upon.

Any elector qualified to vote for Overseers may prepare his hallot for the purpose of voting by marking, in the square provided therefor, a cross (×) at the right of the name of each candidate of his choice, or by writing or inserting the name of any candidate not printed in the official ballot, in the blank space provided for the purpose, and by marking a cross (X) in the square at the right of the name so written or inserted. He shall sign the ballot with his name in the space provided therefor, January 14, 1924, three Directors of the Association are to be elected by the members of the Association voting by signed postal ballots received on or before June 17, 1932.

The following provisions govern the election:

By a vote of the Board of Directors candidates for Directors of The Harvard Alumni Association to a number not less than twice or more than four times the number of vacancies to be filled shall be nominated by the Standing Committee for Nomination of Overseers, Directors, and Members of the Harvard Fund Council.

The names of the candidates shall be placed on the ballot in the chronological order of the first academic degrees received by them.

The election of Directors of The Harvard Alumni Association shall be by postal ballots received prior to the closing of the polls on the Friday preceding Commencement Day.

Ballots received by mail up to 12 m. on June 17, 1932, will be

The Constitution provides that in addition to nine Directors, elected at large, of whom three are elected each year, there shall be seven other Directors of the Alumni Association, chosen as

One of the Directors shall be a member of the Faculty of Arts and Sciences, appointed by the President of the University; the Directors shall be a resident member of one of the Ha Clubs in New England, selected by the Council of the New England Division of the Associated Harvard Clubs; one of the Directors shall be a resident member of the Harvard Club of New York City, selected by the Board of Managers of the Club; one of the Directors shall be a resident member of the Harvard Club of Boston, selected by the Board of Governors of the Club; and three of the Directors shall be members of Harvard Clubs, selected by the Council of the Associated Harvard Clubs. Checks should be drawn to the order of the Treasurer of Harvard University and mailed to the Harvard Fund Council, Wadsworth House, Cambridge, Massachusetts.

If it is desired to give securities instead of cash, these will be accepted at their market value. The difference between cost and market value of securities so given is not now subject to the profit tax.

It should be borne in mind that charitable gifts, including gifts to these Funds, may now be deducted by a donor up to 15% of his income in the determination of his Federal Income Tax.

Persons wishing to make a gift out of capital should be reminded that charitable gifts are not now subject to the Federal Gift Tax and that charitable bequests are not now subject to the Federal Estate Tax.

The purpose of the 300th Anniversary Fund is to strengthen the life of the University and increase the national scope of its usefulness through the establishment of University Professorships and Harvard National Scholarships. Pamphlets dealing with these subjects will be mailed upon request.
