Dear Mr. Roerich:

Prof. Rahder has brought to my attention that you failed to realize the full Rs 62/4/6 from the University check in the amount of \$13.11 which was sent in payment for a Tibetan Dictionary.

This is unfortunate, but the University Treasurer learned from the bank here that your bill of Rs 62/4/6 should be paid at the rate of .2105 cents to the Rupee. This rate has been steady for many months.

Many regular dealers indicate on their bills at what rate they wish to be paid. Prof. Rahder tells me that you are not a dealer, however, and couldn't be expected to know the practices of commerce.

Since the Treasurer's office pays by check only and does not use money orders, and since the bill is paid so far as they are concerned, Prof. Rahder agrees with me that we will have to reimburse you in another way. I am sending you, therefore, a copy of your book, "Trails to Inmost Asia." This was published at \$7.50, is now out-of-print, and will, I hope, make a fully acceptable adjustment for you.

If I can be of any further assistance, please let me know.
