AGREFMENT, made and entered into this 7. day of August, 1936, by and between MADAME HELENA de ROERICH, of Naggar, Kulu, Punjab, India, hereinafter designated as MADAME ROERICH, party of the first part, and MRS. FLORENTINE SUTRO, residing at the Majestic Apartments, 72nd Street and Central Park West, Borough of Manhattan, City, County and State of New York, hereinafter designated as MRS. SUTRO, party of the second part,

MADAME ROERICH, party of the first part, in consideration of the sum of Ten thousand (\$10,000.) Dollars, lawful money of the United States to me in hand paid, by MRS. FLORENTINE SUTRO, party of the second part, as hereinafter acknowledged, have bargained and sold, and by these presents, do grant and convey unto the said party of the second part, her heirs, executors, administrators and assigns, all her right, title and interest in and to forty paintings representing scenes of the Himalayan Mountains, which paintings shall consist of not less than one hundred sixty (160) square feet of canvas.

That in consideration of the said sum heretofore mentioned the said party of the first part represents
that she is the sole and exclusive owner of the said paintings
executed by Professor Nicholas Roerich.

The party of the first part knowing well that the party of the second part does hereby part with the consideration mentioned herein represents and states that the current market value of said paintings is in excess of the sum of Ten Thousand (\$10,000.) Dollars.

That the party of the first part agrees to have the paintings shipped and safely transported and delivered to the party of the second part or to her order at the Port of New York in the United States of America, at the expense

and cost of the party of the first part and upon the terms and conditions contained herein.

The party of the second part agrees to purchase the said paintings for the said sum of Ten Thousand (\$10,000.00) Dollars, payable as follows: The sum of Fifteen hundred (\$1500.00) Dollars upon the execution of this agreement, the receipt whereof is hereby acknowledged, Three thousand, five hundred (\$3,500.00) Dollars upon the delivery of said paintings in good condition at the Port of New York provided that the party of the first part delivers to the party of the second part an insurance policy covering every and all insurance of the said paintings and that the insurable interest shall be in the name of the party of the second part, and upon the further condition that all shipping and freight, costs and all other charges, such as duties and taxes shall first be paid by the party of the first part. That the balance of Five Thousand (\$5,000.00) Dollars is to be paid at the option of the party of the second part subject to the acceptance of the said paintings by the party of the second part within twelve months from the date of the delivery of said paintings.

It is further agreed and understood that the party of the first part shall deliver the said paintings at the Port of New York to the party of the second part within three (3) months after the execution and the acceptance of this agreement.

It is further understood and agreed that when and if the said paintings arrive at the Port of New York, the party of the second part shall have the right to examine, inspect and also appraise the said paintings to ascertain and determine the actual market value.

In the event the party of the second part shall find herself to be unable conveniently to pay the

last mentioned amount of Five thousand (\$5,000.) Dollars within the said period aforementioned, then and in that event it is mutually understood and agreed that MRS. SUTRO shall deliver to the party of the first part, or to her duly authorized, lawful and legal agent, such number of said paintings as she, MRS. SUTRO, shall in her sole judgment, deem adequate to represent the sum of Five thousand (\$5,000.) Dollars and to relinquish, transfer and set over to the said duly authorized legal agent all of her right, title and interest to said paintings so to be returned; said paintings so to be returned shall under no condition be delivered to any person other than the party of the first part, or her duly authorized legal and lawful agent and unless such agent has in his or her possession a duly, legal, authorized and authenticated power of attorney, properly and legally executed in accordance with the laws and statutes of the State of New York.

In the event that the party of the second part shall ascertain that the warranties made by the party of the first part are not as represented herein, then the party of the first part agrees to return and repay to the party of the second part any and all sums of money heretofore paid under and pursuant to the terms of said agreement.

The party of the first part covenants and agrees for herself and her heirs, executors, assigns and administrators to warrant and defend the sale of the said paintings unto the said party of the second part, her executors, administrators and assigns against all and every person and persons.

I, MADAME HELENE de ROERICH, residing at Naggar, Kulu, Punjab, India, being duly sworn, deposes and says:-

I am the same person who executed the agreement made and entered into between myself and FLORENTINE SUTRO of the Borough of Menhattan, City, County and State of New York, simultaneously with this sworn statement dated August 1936, and that I am the sole and absolute owner of the property described in the said agreement and havefull right to sell and transfer the same.

That the said property consisting of forty paintings and each and every part thereof is free and clear of any liens, mortgages, debts or other encumbrances of whatsoever kind or nature.

That she is not indebted to any one and has no creditors.

That there are no judgments existing against her in any Court, nor are there any replevins, attachments or executions issued against her now in force; nor has any petition in bankruptcy been filed by or against her in the United States or in India.

That this affidavit and statement is made for the purpose and with the intent of inducing MRS.

FLORENTIME SUTRO of the Borough of Manhattan, City, County and State of New York, to purchase the property described in the said agreement, knowing that the said FLORENTIME SUTRO will rely thereon and pay a good and valuable consideration therefor.


