"Now regarding the photographs - Sena asked me to write to you that I gave George a folder of photographs which included the few which he recently sent over to you. In this folder were some others of relatives, cousins etc. but I do not recall seeing any more of the children than the ones George sent you. Besides, I am sure George would have sent you all photos of the children. - I have also looked again in my apt. for the photos. Sena asked me how I happened to have these photographs and whether you, dear Mother, did not give them to me originally, which I denied. Only recently shortly before Father's arrival, I spoke to Sena by phone and said "I have some photos of Mme R's family, don't you, Sena, want to look at them again? To which Sena answered, "oh no, I sent Mme R. the duplicates of all the photographs she wanted".

"Sena said that she was concerned about the responsibility of the original letters of yours and Fathers which were locked away in special cabinet upstairs, and since she has no safe place in her apartment would I not take care of these letters, to which I agreed and Av. and Rad. brought all the letters to our apt. If you approve it, beloved Mother, I shall be most happy to safeguard these letter, They were given to me not in chronological order, but I shall put them in order in dates and years myself. Your letters, dear Mother, are the holy of holies to us. "
