

- 1) 24 Feb 1927 (L.L.H.'s letter in own handwriting addressed to Prof.R.)
 (Report on Institutions) "I cannot speak too highly about L.(S.R.)'s
 work in Corona Mundi. In every way he has worked for its upliftment.
 He has taught me a great deal I watch him constantly so as to
 absorb as much as possible. In hanging or pictures, in improving my
 aesthetic taste, I am deeply indebted to him."
- 2) Dec.12, 1930. (L.L.H.'s Report #2) "Mr.S.Roerich is cooperating in every way, in the fix friendliest way, bringing new temnants to the building and making many new friends for our institution."
- 3) June 8,1931 (L.L.H.'s letter in own handwriting). "There has come a complete break in the friendship of Svetik and Mrs Rambova. A certain amount of unpleasantness accompanied this break in their relationship, which showed Miss Rambova and T.M. in a very bad light. Svetig suggested that it would be best to release Miss Rambova from her lease which still has three and thre quarter months to run. Up to Oct.lst,1931. Svetig gives us art objects to cover this loss to the R.M.Appartments, as he personally wishes to assume the responsibility. To have her out of the building is surely for the best."
- 4) Aug.19,1931 (L.L.H.'s Report #11). "It gives us great joy to include an article which appeared in the N-Y-American Aug.15,1931 and written by Mr.W.B.McCormick about the portrait Mr.S.Roerich completed before he sailed, of Mr.Horch".
- 5) June 6,1931 (L.L.H.'s Diary letters) "Svetig's friendship with with Natasha R.came to an unpleasant ending. TM played the park perfect part of a betrayer. Svetig told TM what a fine person and good friend Katherine was. TM advised Svetig not to tell this to Natasha, however TM went and told this to Natasha. This started the break."
- 6) July 18,1931 (L.L.H.'s Diary letters) "Svetig is busily preparing for his journey I shall miss him greatly."
- 7) July 1,1931 (L.L.H.'s diary letter) "My brother Svetig has passed through difficult moments. I feel a great love and inner tie with Svetig.

 And I am happy that we spent much time in each other's company.

 Miss R., we understand, sails this Saturday. TM and NR have shown themselves in their full glory. We should all rejoice that they are not living in this building any more. In every way our Svetig acted like a Gentleman and showed the nobility of his spirit and in every possible way. TM and NR have tried to harm, demean and belittle him. Our Svetig treated them with the utmost courtesy and friendliness; and they in turn showed the smallness of their spirit. Svetig's friendship with N.R. really amounted to little, yet in every way they attempted to capitalize it. Svetig is the Victor in every way...I will help Svetig any time, any place in the world."

I am very happy that a French physician is coming out here for the same of Mme Roerich, as the condition of her health has alarmed me greatly, Mme Roerich suffers at present from the vomitting spells, which she also had at Keyland, but which have great increased, since we are back at Naggar. A few days ago Mme Roerich vomitted with blood and this worries me very much. The strain of the vomitting spells has caused her a sharp neuralgic pain in the back and in the appendix thus disabling Mme Roerich to move.

Excerpt (original on hand).

Sunday, Naggar, Nov.16,1930

Dear and beloved Prof. Roerich and George.

From my telegram I have sent you today you know of the terrific fright we lived through this night. The worries on account of the detention of news about your arrival at Pondicherry and the constant expectation of news from you about your coming home have so reacted on Madame Roerich's heart that yesterday after a vomitting spell she had a swoon with the heart almost completely stopping. It happened after 11 o'clock at night. All people and servants returned and were asleep. We had to awake them all to warm water and to prepare some very strong coffee. We applied hot applications at hands and feet to help the circulation of blood, gave strong stimulants and treatment and brought the heart to function. I cannot describe to you the agony we were in until Mme Roerich recovered, not only we were in agony but all our servants were standing shivering and some of the most faithful ones were crying, fearing for Mme Roerich's life. The girls and I were up the whole night watching Mme Roerich closely. Towards the morning she had a little sleep but feels very weak and exhausted, endures pains in the heart and her pulse is weak and very irregular.

My heart aches, dear Prof.Roerich and George, for Mme Roerich and you both. Rest assured that we shall stop before no means, we Americans, to vindicate your great and reverenced by all of us name.

28) From Mr.L.L.H's letter, Debruary 14,1930. "My Own Dearest Beloved Mother, It is the greatest happiness for me that P. (Nettie) is now with you..... Dearest Mother, how I bless you for writing these divine letters to us. ... To you, Dear Mother, we owe everything. You and Prof. Roerich have opened the Gates to us - you have shown us the higher path and have brought us to the Great Teacher. To thank you in mere words is impossible. Be assured, Dear Mother, that I will do my utmost to carry out Your Commands. Everyone of your advices and Suggestions came true. I will do everything in my power to bring greater unity into the circle.-Please point out to P. (Nettie) how you would like me to develop .- Professor Roerich has worked terribly hard and has accomplished wonders. I so wish he should not tire himself. Dear George has become an idol - he has appointments from morning until night. Dear Svetig is doing interesting research work and working hard on the coming auction. Oh how much I miss Dear O. (Esther).

Dearest Mother, P. (Nettie) will tell you all details - again my deepest thanks for all that you are constantly doing for us. Your beloved

son - L. (Louis).

We all pray that your health will show improvement. "

1) President's

Report No.17, May 28, 1931. item "House next door". "As we cabled to you we purchased the house 321 West 103rd Street subject to the following conditions; The price paid for the house is 27,000, subject to a first mortgage of 13,400, held by the Guardian Life Insturance Co. We agreed to pay 4500 cash, of which 1500 is to be paid upon the signing of the contract and the balance of 3000 is to be paid within 30 days after signing of the contract and upon our taking title to the building. It is understood that the owner will give us a second mortgage of 9100 for five years without amortisation with interest at 6%. It was also agreed that taxes: real estate, water, etc. are to be prorated. As cabled to you Catherine has donated 1000 as a gift and has loaned us three thousand dollars. She has also made the provision that if it is possible she will donate still more of the three thousand to the institutions. We shall try very hard to rent out this house as it was purchased at a reasonable price. There is no reason why a very nice little income should come from it to the Museum. For instance, Dr. Kettner approached me without knowing anything about the house, and said that some of his students would like to live nearby. Perhaps they would be interested. "

- 2) President's Report #18, June 2, 1931/. "Purchase of house, 321 West 103rd Street. Yesterday a contract was signed for the purchase of the house next door. We shall take title on June 29, 1931 and the present owners will leave the building on Sept.15,1931. As soon as we take title on June 29th, we shall get in touch with many real estate agents, for the purpose of renting it out. "
- 3) Minutes of the Board of Trustees of Roerich Museum, May 28,1931.: para 16:
 "Mr.Horch Reports the purchase of 321 West 103rd St. for \$27,500
 Catherine Spencer donated \$1,000 and loaned \$3,000 for the necessary
 cash payment"... Signed L.L.Horch, N.S.Horch, M.M.Lichtmann, Sina Lichtmann and Frances R.Grant.
- 4) Cable received on May 28th and 29th May 1931:

 "Adjoining house purchased for twentyseven thousand dollars of which fortyfive hundred payable in cash Horch"

 "Catherine donated onethousand dollars and loan threethousand dollars for purchase of building Horch".

 These were acknowledged in our Minutes #24, Roerich Museum Meeting, May 26-29 1931 and "Sincere thanks were expressed for the donation".
- 5) President's Report , June 8th, 1931:

 para 2 " Catherine Spencer:

 "Miss Catherine Spencer requested the return of \$500

 against the money loaned and this was granted. This was withdrawn against the \$10,000 which as has been mentioned in previous letters is a temporary loan to the Institutions."
- 6) President's Report #4, June 25,1931: "Catherine Campbell.

Miss Catherine Campbell gave instead of the \$650 about which I wrote you some time ago, a check for 700\$. Today Miss Campbel presented another \$300 to Urusvati, which is to be used for any purpose, which may seem fitting to the Trustees. Miss Campbell rejoiced greatly that the donation of \$650 as mentioned in the Minutes of the 26th Meeting of Urusvati will be used for special studies of Tibetan Medicines.

Excerpt from Minutes of the 109th Meeting of the Trustees of Roerich Museum,

July 1st, 1931

39) Regarding paragraph 3 of the same suggestions, since the arrival of Professor and Mme Roerich's request we have been trying to collect and assort all manuscripts, letters etc. in order to put them into the vault. Already quite a number of letters and manuscripts have been put in there and we hope shortly to complete it.

\$200,000 represents Purchases of Paintings. The \$200,000 Principal or Capital was donated by Prof. Roerich with the understanding that 4% interest per year should be paid to Prof. R.

The \$21,086 are Trip Expenses of Prof. Roerich to the United States and Return to India (1929-1930). The Capital Sum of \$21,086 was donated and Interest of 4% to be paid to Professor Roerich.

At the time when these financial transactions were made the Capital sums of \$221,086 and \$636,271.55 were denated outright and Interest of 4% per Annum was to be paid to the Donors. These are transactions of the same type as "Trust" and Annuity agreements. Donations of Capital the Auditors felt, could not be placed on the Books as Loans. However as the Interest has lately not been paid to the Donors the Writer will ask the Our Attorneys if on account failure to pay the Interest the Capital Sums now fall due and the Item "Donation" could be changed to "Loan".

The Item of \$300 referred to in this Paragraph is a Loan of Prof. Roerich's made by him to the European Center.

We shall send Mr. L. Kirstein the data about Stravinsky and "Sacre du Printemps which Prof. Roerich was kind enough to send.

Mrs Horch is especially grateful for the spirit of courage and joy which our leaders have imbued us, and which we have aimed to transmit to our new friends and co-workers."

p.32 - "Mr.Horch states that at the last Meeting of the Trustees in the year of 1933 the Chairman thanks the Trustees for the work accomplished in 1933. The highest achievement accomplished was the Roerich Peace Banner Convention on Nov.17th. The Chairman feels that with the glorious guidance of Prof.and Mme de Roerich and a full-hearted cooperation of the trustees the year 1934 will far excell the year 1933. We know that the Banner of Prof.de Roerich will be unfurled in this coming year. On this closing day we hail joyously our great Leaders, Prof.and Mme de Roerich. The Trustees heartily and enthusiastically join the Chairman in the same invinsible faith, in the great future of the Roerich Pact and Banner of Peace, and all our actions under the great guidance and Leadership of Prof.and Mme de Roerich."

 pare 13. "Referring to para 50, the Trustees realize fully the serious financial damages caused by the failure of the American Bond and Mortgage Co. Their returning to us over \$300,000 of unsold bonds on which we took a loss of over \$150,000. Besides which their huge finance charges of 10½% for floating our Bond issue and their usurious charges of approximately \$142,000 for building charges, have been grossly affecting our works, which otherwise are on such sound bases. " (Re Reorganization)
- 7) Minutes 171, April 3, 1932 para 12 The following wire was sent to(all persons concerned with the reorganization): "We have received notice from Mr. Rickaby of Simpson, Thatcher and Bartlett that you have decided immediately to appoint receivership on the 103rd Street and Riverside Drive building Stop Trustees of the Roerich Museum wish to warn you of the disastrous effects of such action for our entire building and the bondholders for which we will hold your committee responsible Stop As already expressed to Mr. Rickaby we are ready to put up necessary sum for settlement of debts. Stop As you are well aware our present situation is due to failure of the American Bond and Mortgage Co to fulfill its obligations to us in returning \$320,000 unsold bonds to us Stop We also wish to warn you that you are taking this actions during the active development of our campaigns for funds, while we are appealing for total tax exemption and on eve of the renewal of leases and your action threatens to destroy success of all these movements. In view of these circumstances and since an assignment was made out only two weeks to the Manufacturers 'rust Company, Trustees of the Mortgage, we wish to state that this action is entirely unjustified and we will hold the members of your committee responsible Stop In view of our readiness to settle our debts we therefore urge you to revoke immediately your decision for appointing a receivership which we understand is to take effect on Monday morning, April 3rd. In behalf of Trustees Roerich Museum - Louis L. Horch President." (Re reorganization).
- 8) Minutes 174, June 11,1932.

 "Being that Mr. Horch was always in charge of the building, he will ask for \$12,000 remuneration outside of educational expenses.
- 9) Minutes #179, August 6,1932.
 para 20. "The payroll of Roerich Museum Appartments has been decreased to approximately \$61,000 per year. This was formerly 109,000.-"
- 10) Minutes #180, Aug.17,1932.

 para 4 Telegram to Hon. John Curry, Aug.10,1932: describing illegal receivership: "His (Philip Curry's) three months of illegal receivership: and corruption in this building, and brought protest from tenants, bondholders and cultural leaders".



11) Minutes #197, Jan.8th 1933.

para 13

"The trustees deeply appreciate the Indication and suggestions contained in the first paragraph (of Naggar Minutes #11) . We will have the attorneys look into the question of starting lawsuits against the dishonest contractors, recommended by the American Bond and Mortgage Co. All possible evidence shall be gathered together to expose this rings of racketeers. Through such facts public sympathies shall be aroused for our Cause Celebre. A number of the Societies will claim damages for impeding their cultural activities and harming of their raising of funds. The Master Institute will point the loss of students, which caused a substantial loss in the income of the school. All these great losses were caused by the illegal actions of the Hazlewood Committee and the Manufacturers Trust Co.

12) Minutes #198, Jan.15,1933. para 16.

"Re para 2,#12 (Naggar Minutes) in regard to the law suit of \$500,000 brought against the Hazlewood Committee the attorneys advised us that in these first papers only the Friendship Bond Committee was mentioned. When the lawsuit will come up for trial statements from all the Campaign Committees will be presented for evidence. At that time also the K-evidence will be presented to the court. In regard to the Hartmann Committee's action this is a lawsuit to have the bonds now deposited with the Hazelwood Committee, turned over to the Hartmann Committee. The Claim being that the Hazlewood Committee received these bonds based on false statements made by the Hazlewood Committee to the bondholders. No money is involved in this legal action. We will secure a copy of the legal papers."



20) L.L.H's Diary letters. Feb. 4 1931. "Received the beautiful letters from our Guru (N.R) and Tara (H.R.) I deserved a much severer letter, then the the beautiful letters received. From the moment almost when I met Prof. R. I had only one wish namely to gather all Paintings of Prof.R. in one place, so that no one should ever get them. To keep these Treasures for Humanity for all time! And what did I want to do, to sell a few of them to help some temporary condition. I am heart broken at my great stupidity! How sad I was when some pictures were sent on Loan to South America! It is sad to think how small my thoughts became. When once one thinks in this low Scale one naturally makes other mistakes. Just as stupid was to use different Lighting in the Museum. Certainly I want to go only by the High Road of Hierarchy - and it is the great priveledge to go by this Divine Path. To respect and honor every Indication by the Guru and Tara and to protect their Name with my life.

One special priveledge given to me was to take all financial worries of the Hands of the Guru and in a moment I spoil anything. To be economical in our Institutions instead of seeing where the real Economy was needed. namely in the Hotel. I can assure My Teachers, that this row of errors made by myself exclusively were not made intentionally or consciously. I am guilty of these errors and I shall torture myself to learn how to think and act better. Also before acting to look at all possible consequences, Once at Santa Fe I made an unprepared speech and this speech was very bad. Now I always prepare speeches and this error once made at Santa

21) L.L.H's Diary letter, July 21,1932. "I saw Ernst later in the afternoon

Fe, never fails to rise before my mind . - "

and he told me he could not bring these serious charges, although he admitted that we received 'a raw deal' from the Bank and Rickaby. He felt a certain 'Emotion' for J.Johnson, Trust officer of the Manufacturers Trust Coy, also for X, who may get into some trouble and he would not like to see Rickaby disbarred!!! Ernst has real sympathy for Rickaby!!! Ernst known as a great fighter and fearless attorney, becomes apologetic when it comes to fighting a big bank!!! Ernst knows in his own heart that the whole thing is a conspiracy. I am greatly disappointed in Ernst. This was a great opportunity for him. Ernst prefer to protect his own personal friends in the Manufacturers Trust Coy". July 25,1932. "Ernst is sympathetic to the Manufacturers Trust Coy his fee also concerns him. " - "Mr. Lyeth is the man before whom Ernst Greenbaum and Schur bowed with such reverence, they were warned by us time and time again of Lyeth's duplicity" - "Ernst left New-York without saying goodbye". July 27,1932 "We were especially concerned because Schur is a young inexnerienced lawyer and he is certainly no match for the experienced and crooked Lyeth. Of course Stern coaches Schur what to say to Lyeth, still many stupid things were uttered by Schur to Lyeth. " - "Stern mentioned to us that when Lyeth asked Schur why are you insisting on the delay of the appointment of the receiver until August 1st?, Schur replied: "because we feel more secure" - how stupid and ridiculous. - The best answer was . that Ernst and Greenbaum only returned beginning of August". July 28. 1932. "Early in the morning I again called up Schur and asked him to write a letter to the judge, but he again refused stating he wishes to wait - a very stubborn young man. This is so often my greatest worry to

make others execute our Orders - this often takes great tact, patience and

July 29,1932. "Schur, Ernst, Greenbaum are all away on vacations - it is a good thing we do not depend on them alone, we would be lost - imagine if Lyeth breaks his agreement and should apply to-day for a receivership, not one of our attorneys are here!!!"

August 1,1932. "Certainly Greenbaum is not a great genius, when it comes to law and he must become very careful in dealing with the suave Lyeth. I always feel Greenbaum talks too much and gives too much of our business away to the other side - but he is being trained and he is learning. "

Aug. 9,1932. "Our attorneys believe in Mr. Lyeth, I told them they were children! Lyeth is just playing with them as if they were babies.

22) Sept.21,1932"Schur of Ernst's office told me to-day that it is always best

to let the other side strike first!!! (A fine aggressive lawyer!!!) " Sept. 23, 1932 - "Hartmann advised me that he may serve on another committee where he would work with Rickaby on the same committee!!! I will speak with Ernst regarding this matter." Sept. 26, 1932 - "I asked Ernst's opinion about Hartmann also being one a Committee with Rickaby? Ernst replied 'that's perfectly O.K., I am also on a Committee friendly to the Manufacrurer's Trust Co.'!! His love for the Manufacturer's Trust Co can easily be understood. First - Hartmann on same Committee with Rickaby, two - Ernst on another Committee with the Manufacturer's Trust Co, three - Stern and Lippman might be together with Carter, Ledyard and Milburn. This last part is still under consideration. Despite these interrelationships we shall win. "Oct.7,1932 - "Hartman showed his true self. Always ready to sit down with the enemy, instead of disabling the enemy. - This time Hartman did not get away with his'sitting down'with Rickaby - Hartman is also jealous that Ernst received this publicity. The above-mentioned excerpts represent only a small part of endless superlative utterances in the same style, as in the letters from Mr.L.L.Horch himself, so also in the letters from Mrs N.S.Horch and Miss E.J.Lichtmann. And now having for thirteen years up to the middle of 1935 expressed gratitude and highest appreciation for the valuable guidance and assistance to Prof. and Mme de Roerich, Mr.L.L.Horch suddenly, already after the return of Miss E.J.Lichtmann to New-York, without any change of policy or attitude on our part, performs a volt-face and expresses the following absurdly contradictory to his own previous conviction and statements, sentences:

- 17) "Mr.Horch wishes to remind the Trustees that during all these years Prof. and Mme de Roerich have imposed upon us the necessity of accepting all their ideas, suggestions and plans, backing them up with "indications". We were forced to accept their advices and opinions even though they often did not meet our sense of logic, reason and common sense "(Minutes #350 N.Y. August 29th 1935, signed L.L.Horch, S.Newberger and E.J.Lichtmann).
- 18) "In conformity with my recent letters and entries in the Minutes, I wish to advise you further that your ways of action are not my ways and that our relationship has come to an end. We shall no longer accept your leadership and the breach between is is irreconcilable. We have ample causes to reach this conclusion. In serving the works under your leadership, we have expected that high spiritual principles would be brought into actuality, but instead in the works we have experienced the most deplorable and the reverse aspects of human relationship and life. Such lack of logic and principles as evidenced by all the above contradictory statements, compels to conclude that one has either to do with a maniac, or with a premeditated evil machination for ulterior purposes, and in that case all previous superlatives were deceit and treason.

Please pay attention to the passage about taxes in this letter of March 20, 1935. It is very characteristic that LLH having received our information that on March 20th we go into the desert, writes to us about that which he usually did every year himself. It is also characteristic that he writes that extension has been granted without stating for what period. In my own handwriting I had informed him that I receive \$237 for every two weeks. Upon return to India my first step was to cable to Mrs Lichtmann about my taxes for 1934. I could no longer write to LLH as he had already suddenly in a most rude form severed connections.

"In case you wish to file an income Tax Statement for the year 1934, an extension has been granted to you to file it. If you desire me to take care of it for you, please write me your income and expenses for 1934.

Oj.and myself visited S and we informed him of the new attacks. We presented him with the Newspaper (sent us by N.K.) which contained the attack against the Pact. He was inquisitive to know as to why the visit to H.took place, as it is known as "the worst melting pot".
