We will continue to regard our affiliations with you and Mr. Lichtman as representing the highest interests of the Museum and do feel privileged to write me if I can ever be of service to you both. I have not really known Mrs Lichtman - but I am so certain working so unitedly with her husband - you will all come through this ordeal with inner illumination and victory.
