Mar. 18, 1931

Paintings. On our books we have been carrying an item of \$5,000,000 which represents the value of paintings in the Museum. This evaluation was placed at the time when we received our loan from the Chemical Bank and Trust Co. Will you be good enough to advise us if we should continue to carry this item on our books?

Letter No. 4, page 2)

March 25, 1931

2nd Mortgage Bonds. East Trustee was given 2nd Mortgage Bonds, due them for the past year. I have placed apart in a vault 2nd Mortgage bonds for yourself, Mrs. Helena Roerich and Dr. George Roerich, due you for the past year. Each month the \$200 for each trustee will be put aside as you have indicated.

Letter No. 5, par. 7.

March 30, 1931

Administration. In connection with the 2nd Mortgage Bonds which are given each month to each Trustee, do you desire them to pay 4% interest, or should they pay 6½% (Int. at 6½% is printed on the bonds). We shall appreciate your advising us about it (See also letter May 6, 1931)

April 10, 1931

Now, however, Corona Mundi Inc. has been dissolved.

Letter No. 9

April 23, 1931

We have today deposited to your account in the Chemical Bank and Trust Co. \$4421.72 which represents interest due you for the first half of 1930-31.

May 11, 1931

Mr. Newberger comes at an average of two or sometimes three meetings per month.

Aug. 22, 1930

Decided not to let my mother as well as sister live at our Hotel - they would be too gossipy and cause difficulties.

Oct. 16, 1930

All financial needs of Prof. Roerich and Mrs. Roerich shall come from now on from the Roerich Museum, because Professor Roerich's private bank account has been so heavily burdened during the last few years.

Nov. 13, 1930

We gave 2 rooms to my mother and father in the hotel. Would have preferred them not living so close, but we save \$1700.- per year and at this serious financial time we have no right to waste money. They will not bother us. They are already well trained.

Dec. 5, 1930

Perhaps we could sell a few pictures in the Museum telling people they are on "Loan Exhibition".

Nov. 16-17

This evening Mrs. Schafran resigned her work in the Museum. She spoke very nicely. We will no doubt let Mr. Koerber handle the cleaning of the Museum

Nov. 29, 1936.

The law suit of Mrs. Schafran was settled for \$350.- and after Nettie speaking boldly pointed out her responsibility in this matter. That we cannot shove our faults upon the Museum - Mrs. Schafran after "a conference" with Sina decided to personally pay the \$350.00 When you take money from people in America it will never be forgotten. Dec. 3, 1930

Mrs. Schaffron's lawsuit has been settled for \$550 and she herself intends to pay for it. It is much wiser to settle this because otherwise the lawyer fees will eat us up.

June 3, 1931

My dear Prof. Roerich:

The complex situation which has arisen in regard to Urusvati Himalayan Research Institute because of the still unsettled land issue is one of a serious nature. You can readily understand our deep responsibility to the people who have contributed so generously for this humanitarian work. The donors are now questioning us as to the results and plans for its development. We had conveyed to them your conversation with Lord Irvin and the other officials of the Government of India in which they expressed their approval of the development of a scientific research institute at Rulu. Naturally, your generous gift of land and buildings further confirmed their belief and interest in the great work for humanity which could be accomplished there.
