and I acknowledge with thanks receipt of your reply as follows:

"Do you refer to deposition for court or tax return or other declaration Stop If former as court appoints commissioner suggest you cabling attorney arrange appointment Consul Karachi - Amconsul". (Though this wire was sent by you on the 25th at 10.55 a.m. it reached me only on the 27th at 12.30 p.m. because owing to snow avalanches in the hills here our postal and telegraphic service was intertupted for a few days).

Following your kind suggestion I have cabled to my attorneys in New York asking them at the same time to have the date of the deposition in Karachi postponed for a fortnight, because of Madame Roerich's illness.

Sir:

Reference is made to my telegram and letter of yesterday regarding the Commission issued by the Board of Tax Appeals to take your deposition. A telegram was received this morning which reads as follows:

"American Consul Calcutta

Board Tax Appeals ordered Roerich deposition taken before Consul Karachi send papers Karachi - Plaut and Davis"

I have just telegraphed you as follows:

"Roerich Naggar (Kulu Punjab)

Telegram from your attorneys requests send Commission Karachi Letter follows - Lane American Consul

The Commission which is now in my possession, is directed specifically to "The United States of America Consul of Calcutta, India! and requires that the testimony be taken at Calcutta at 10.00 o'clock a.m. on March 15. The usual procedure requires that no one but the person named can act on a Commission to take testimony, and the terms of the Commission itself contain no authority for changing either the Commissioner or the place stated.

The certificate which must be filled out by the Commissioner reads

as follows:

"I, the person named in the foregoing order to take depositions, hereby certify" It is obviously impossible for anyone but the person named to fill out this certificate and any variation from the prescribed form may

result in voiding the deposition.

Presumably Messrs Plaut and Davis have arranged for the Commission to be taken by the American Consul at Karachi in spite of the apparent irregularity of this procedure. The normal procedure would be for a new Commission to be issued naming the American Consul or Vice Consul at Karachi as the Commissioner, and designating Karachi as the place where the testimony is to be taken. By naming both the Consul and Vice-Consul it is possible for either to act as Commissioner, in case one of them happens to be unavailable on the particular day upon which the testimony is to be taken. If only one officer is named and that officer is not at his post, the testimony cannot be taken.

In forwarding the Commission to Karachi, it must be understood that all responsibility for possible difficulties is assumed by you and your attorneys, and neither this office nor the Consulate in Karachi can give you any assurance that the Commission will be accepted by the Board of Tax Appeals. I would strongly suggest that you communicate with your attorneys before you go to the expense of having the deposition taken

at Karachi on the present Commission.

The procedure of the Board of Tax Appeals may vary from that followed by most courts and, as mentioned above, it is presumed from their telegram that your attorneys have arranged for the acceptance of the present Commission when executed by a person not named therein. As the entire procedure is being effected on behalf of you and your attorneys, I am following their instructions in regard thereto and am forwarding it to the American Consul or officer in charge at Karachi. It would be well for you to obtain from your attorneys specific instructions as to the wording they desire to have followed in lieu of the prescribed form which I have quoted above.
