- 6. Are you the owner of certain manuscript diaries written in your handwriting and contained in copybooks containing dates beginning with March 24,1920 and continuing through to and including Feb.3,1935.?

 Yes.
- 7. If your answer to Interrogatory No.6 is in the affirmative, describe in detail the appearance of said copybooks.

The first lot of manuscript diaries was written mostly in copybooks with black cardboard covers, of American make. They were written in my handwriting, in larger writing and in old Russian orthography. They were sent to America from India, via Italy in 1925. The later lot was written in manuscript books of French make, much thicker, in flexible black oil-cloth covers and the text was written in the new Russian orthography and in smaller handwriting, in order not to make them too bulky. All were throughout in my own handwriting. The last copybook closes with my diary of Feb.3rd 1935, is of slightly larger size, in blue cover, with gilt frame line on the front cover. The approximate size of the manuscript books is about 9x7 to 10x8 inches.

Yes, throughout.

Philosophy and ethics, historical traditions and prophecies, apocryphs and legend lore and private annotations.

11. Was any portion or portions of said manuscript contained in said copybooks published?

Yes. Special selections, chosen and edited by me.

- 15. If your answer to Interrogatory No.14 is in the affirmative, did you have any conversation or conversations concerning said copybooks with Esther J. Lichtman at or prior to the times when you delivered any of the said copybooks to her? Yes.
- 16. If your answer to Interrogatory No.15 is in the affirmative, state: a) the place or places where such conversation or conversations took place; b) the date or dates when such conversations or conversation took place; c) what was said by you and what said by Esther J. Lichtmann in such conversation or conversations; and (d) what, if anything, took place at or following said conversation or conversations.
 - (a) here, in my home in India.

(b) during 1930-1931 during Miss Lichtmann's stay here and before her departure in Sept.1931 to New York and again in Feb.1935 before her departure to New York.

(c) Formerly all manuscript books of earlier dates were kept by Mrs Sina G. Lichtmann in New York, and about 1930 they were all handed over for safe keeping, on my behalf, to the Trustees of Roerich Museum, who kept them in a special place in the Museum's Building in New York for me. In 1930 and 1931 we had here in India a conversation with Miss Esther J. Lichtmann, that Mrs Horch considers the safe keeping of my manuscript books in the special place in the Museum's Building unsafe during the summer time and she, Mrs Horch, has suggested that all manuscript books should be taken over tp her, Mrs Horch's appartment in the same building, in order to be transferred later to a safe or vault, taken in my name. With this I agreed. When handing over further manuscript books to Miss

Lichtmann before her departure in Sept. 1931 to be taken to New-York I told her that these were to be added to the others and were all to be kept as my property in safe keeping until I need them and I told her that they were to be kept sealed. Miss Lichtmann promised to do so and to hand them over for such safe keeping on my behalf, to Mrs Horch. Thus in 1931 all my manuscript books were taken over for safe keeping on my behalf, by Mrs Nettie S. Horch. A vault was then taken in my name for their safe keeping for which purpose I authorized one to be secured from the Chemical Bank in New-York. This was confirmed by Mr.Louis L.Horch in his "resident's Report" of Oct. 1932 signed by him. Further confirmation is found in the following two reports: From Mrs Nettie S. Horch, June 28, 1931 para 3: "before leaving New York for Moriah on June 14th, Mrs Horch asked all Trustees to bring all letters, books and manuscripts of Prof. and Mme Roerich to the place agreed upon, so that we can cable a reply to Kulu that this was done as requested". And a cable was received from New-York #1185/9 dated July 9th 1931: "DLT ROERICH NAGGAR - All manuscripts letters put safe - Sina" (Sina Lichtmann). According to the Chemical Bank's statement rhe vault was discontinued by Mrs Horch (without my knowledge) on March 16th 1934. In 1934 Mrs Horch wrote me a letter, dated March 31. in which she stated: "Dearest Beloved Mother, It is wonderful to have our beloeved Father and George with us and to receive the wise Guidance and advices of our beloved Leader.... I shall take the original books from upstairs into my appartment as was suggested.... "Thus my original manuscript books as above stated since March 1934 were in Mrs Horch were in Mrs Horch's sole safe keeping.

In Feb. 1935, when Miss Lichtmann again left from here for New York I again handed over to her further of my manuscript books which were to be added to those previously sent and were also to be kept by Mrs N. Horch in safe keeping on my

behalf, and sealed, what Miss Lichtmann again promised to do. (d) In both cases (Sept.1931 and Feb.1935) Miss Esther J.Lichtmann took along on her way to New York manuscript books from me, promising to hand them over, as above stated, for safe keeping, on my behalf.

(c) It was also said that the manuscripts books are my property, and are taken to New-York only for safe keeping on my behalf. Mrs Horch promised to do so and

(d) took the manuscript books along to New York.

- 19. Did you ever deliver any of the said copybooks to Nettie S. Horch or Esther J. Lichtmann, except by delivering them direct to either or both of said persons? - Yes.
- 20. If your answer to interrogatory No.19 is in the affirmative, state (a) the number of said copybooks; (b) the dates when and (c) the name of the persons by whom you delivered the said copybooks to Nettie S. Horch or Esther J. Lichtmann.

(a) All my previous manuscript books, beginning from March 24,1920. Thus together with those mentioned in answers No.16-b abd 18-b, the entire unbroken series from March 24,1920 to and including Feb.3,1935 were delivered for safe keeping on my behalf. The total number is several dozens, and being in form of a diary, each subsequent manuscript book is by date a continuation of the previous book and there is no break in this continuity - thus the completeness of all manuscripts can be easily checked from beginning to end - from March 24,1920 to Feb.3,1935. The date of the first page of each manuscript book can be checked with the last date on the last page of the previous book. Besides there is in every manuscript book an inner front page on which the date of the beginning and end of that particular book is given and thus the uninterrupted continuity is easily established.

1) In 1925 Mr.V.Shibayev took my manuscript books dating from the 24th of March 1920 to Jan.1925 on his way to Europe and posted them from Venice, Italy to New York to Mrs Sina Lichtmann, who at that time was custodian

of these manuscript booksfor me.

2) in 1927 Mrs Sina Lichtmann took from me personally in Mongolia for same safe keeping on my behalf the next series of manuscript books dated up to spring 1927.

3) in 1929 and 1934 Prof. Nicholas Roerich when visiting New York handed over

further manuscript books for safe keeping.

Thus as stated in par 16-c all the aove were taken over for safe keeping in America by Mrs Nettie S.Horch, including those she herself took from India to New York in Aug.1930 and including those two lots which in Sept.1931 and Feb. 1935 were taken over to America from here, by Miss Esther J.Lichtmann. All these manuscript books together covering the entire unbroken period from March 24, 1920 to Feb.3,1935 in my handwriting, are thus in safe keeping of Mrs Nettie G.Horch. MissEsther J.Lichtmann in two cases was the transmitter.

21. Were you present at a meeting of certain Trustees of Roerich Museum, in Nag-gar, Kulu, Punjab, British India on April 28, 1931.
Yes.

22. If your answer to Interrogatory No.21 is in the affirmative, state who besides yourself was present at said meeting.
Prof.N.Roerich, Georges Roerich, Miss E.J.Lichtmann & Mr.V.Shibayev.

23. If your answer to Interrogatory No.22 is in the affirmative, was anything said or done at said meeting concerning the said copybooks, the subject of

this action? - Yes.

24. If your answer to Interrogatory No.21 is in the affirmative, what was said or done at said meeting concerning said copybooks.

The resolution was passed and sent to New York that "All manuscripts and letters of Prof. and Mme Roerich must be kept in a special vault", and a request was made to New York to confirm this as soon as completed.

And confirmation of this was received in a report by Mrs Nettie S. Horch dated June 28,1931 and in a cable from New York dated July 9th.1931.

- 25. Did you ever instruct anyone on your behalf to make demand for the return to you of said copybooks.
 Yes.
- 26. If your answer to the 25th Interrogatory is in the affirmative, state the name of the person whom you so instructed.

No, none .

1. Are you a citizen of the United States?

No.

2. If your answer to Interrogatory No.1 is in the negative, of what country are you a citizen?

Russian born.

3. What is your present residence?

Naggar, Kulu, Punjab, Br. India.

4. What is the tital number of copy books and/or manuscript diaries in your handwriting that you made?

The exact number I cannot remember because they were sent over a period of many years. The approximate number is several dozens. But the continuity of the manuscripts can be easily checked as on an inner front page pf every manuscript book there is the date of the beginning and end of that particular manuscript book and the uninterrupted continuity of all the manuscript books covers the period from March 24,1930 to Feb.3,1935.

5. Did you make or did you cause to be made any exact duplicates of all of the copy books and/or manuscript diaries which are the subject of this action?

No.

6. Did you make or cause to be made duplicates of any part of the copy books and/or manuscript diaries which are the subject of this action?

Yes, some parts of the manuscripts had been selected by me and were type-written for publication.

7. If your answer to Interrogatory No.5 is in the affirmative, state how many duplicates or copies were made of the copybooks and/or manuscript diaries which are the subject of this action?

No exact copy of the whole exists.

8. If your answer to Interrogatory No.5 is in the affirmative, describe in detail those copy books and/or manuscript diaries which were duplicated, by giving the general content of the entire copy book and/or manuscript diary duplicated, the general appearance of the copy books and/or manuscript diaries, and the dates over which the same covered.

This question does not arise. Besides, I do not claim any copies. I claim the return of my original work, in my own handwriting and in the Russian language, given for safekeeping.

The general appearance of my original manuscript books has been given

in my reply to the Direct Interrogatory No.7.

9. In your answer to Interrogatory No.6 is in the affirmative, state how many duplicates or copies were made of any part of the copy books and/or manuscript diaries which are the subject of this action.

Duplicates of parts have been made in several typewritten copies for publication (on my typewriters). I do not claim these.

10. If your answer to Interrogatory No.6 is in the affirmative, describe in detail those parts of the copy books and/or manuscript diaries which were duplicated, by giving the general content of that part of the copy book and or manuscript diary duplicated, the general appearance of the copybooks and/or manuscript diaries, and the dates over which the same covered.

These parts have been printed as stated in my previous reply to direct interrogatory No.12 and the contents can be seen from these books. The dates over which the same cover are on the books. I repeat that I do not claim any typewritten copies or printed books, but my original manuscript books in my own handwriting.

11. If your answer to Interrogatory No.5 is in the affirmative, state in whose handwriting duplicates were made.

The question does not arise as no exact copy was made.

12. If your answer to Interrogatory No.5 is in the affirmative state how many duplicates of each copy book and/or manuscript diary were made.

The question does not arise.

13. If your answer to Interrogatory No.6 is in the affirmative, state in whose handwriting duplicates were made.

The duplicates of parts, for publication, were made on my two typewriters.

14. If your answer to Interrogatory No.6 is in the affirmative, state how many duplicates of each part of each copybook and/or manuscript diary was made.

Several carbon copies were made, sent to America and other countries.

15. If your answer to Interrogatory No.5 and Interrogatory No.6 is in the affirmative, state how the duplicates were made.

No exact copy of the entire manuscript exists, and the part copies for publication were typewritten with carbon copies.

16. If your answer to Interrogatory No.5 or Interrogatory No.6 is in the affirmative, state whether carbon paper was used in making the duplicates.

Yes, for the part copies used for publication carbon paper was used. I do not claim these carbon copies.

Reference to No.5 does not arise. Typed and carbon copies of parts were usually destroyed after the printed books appeared.

The question does not arise.

21. Is it claimed that the defendant Nettie S. Horch has the original copy books and/or manuscript diaries?

Yes.

22. Is it claimed that the defendant Nettie S. Horch has part of the original copy books and/or manuscript diaries?

Mrs Nettie Horch has the whole original uninterrupted series of manuscript books from March 24,1920 to Feb. 3,1935.

23. If your answer to Interrogatory No.21 and No.22 are in the affirmative describe which copy books and/or manuscript diaries it is claimed the defendant Nettie S. Horch has in her possession.

All the above mentioned (see reply to question No.22).

24. Is it claimed that the defendant Esther J.Lichtmann has the original copy books and/or manuscript diaries?

Miss Esther J.Lichtmann was twice the transmitter of some of the manuscript books for safe-keeping to New York. She was supposed to hand them over sealed to Mrs Nettie S.Horch for safe-keeping.

25. Is it claimed that the defendant Esther J.Lichtmann has all of the original copy books and/or manuscript diaries?

She was not supposed to be the custodian of these manuscripts, but only acted twice as transmitter.

Is it claimed that the defendant Esther J.Lichtmann has part of the original copy books and/or manuscript diaries?

(See above reply to question No.25).

27. If your answers to Interrogatory No.25 and No.26 are in the affirmative describe which copy books and/or manuscript diaries it is claimed the defendant Esther J.Lichtmann has in her possession.

She should not have any of my manuscripts in my handwriting in her possession, as she was only transmitter.

28. If your answer above given indicate that you do not claim that Nettie S. Horch and Esther J.Lichtmann have all or any part part of the original copy books and/or manuscript diaries, who, is it claimed, now possesses all of the original copy books and/or manuscript diaries?

I claim that the entire set of manuscript books, which are subject of this action, should be in Mrs Nettie S. Horch's safe keeping and should be returned to me. If Mrs Horch has not received some of those manuscript books which Mrs Esther J. Lichtmann, astransmitter, took over to her, then Miss Esther J. Lichtman should return such to me.

29. If your answers above given indicate that you do not claim that Nettie S. Horch and Esther J. Lichtmann have all or any part of the original copy books and/or manuscript diaries, who, is it claimed by you, now possess part of the original copy books and/or manuscript diaries?

My above answer to question No.28, applies.

30. If your answers given above indicate that other persons besides the defendants herein possess at the present time all or any part of the original copy books and/or manuscript diaries, describe in detail such original copy books and/or manuscript diaries, possessed by the person or persons indicated, by giving the general content of the copy books and/or manuscript diaries, the general appearance of the copy books and/or manuscript diaries, and the dates over which the same cover.

No, none of the other Trustees have any of these original manuscript books in my handwriting and all of them from March 24,1920 to Feb. 3,1935 must be with Mrs Nettie S. Horch.

31. If your answers to Interrogatories No.5 and No.6 are in the affirmative state whether it is claimed that Nettie S. Horch has duplicates of the original copy books and/or manuscript diaries.

Mrs Nettie S. Horch has the original manuscript books in my own hand-

writing. These were supposed to be kept sealed and not to be read, used copied, etc. Since Mrs Horch does not know Russian, they were of not use to her. She had voluntarily undertaken to keep them safely for me, until I need them.

32. If your answer to Interrogatory No.31 is in the affirmative, state whether you claim that Nettie S. Horch has a complete set of the duplicate originals of the copy book and/or manuscript diaries.

She has the whole set in original.

33. If your answer to Interrogatory No.31 is in the affirmative, state whether it is claimed that the defendant Nettie S. Horch has only a part of the duplicate originals of the original copy books and/or manuscript diaries in her possession.

She has the whole unbroken set of the ORIGINALS in my handwriting in Russian from March 24,1920 to Feb. 3,1935.

34. If your answer to Interrogatory No.31 is in the affirmative, describe in detail exactly which duplicates of the original copy books and/or manuscript diaries are in her possession.

The entire set was described in my reply to direct interrogatory No.7 and it is claimed that she the set of ORIGINALS and not copies or duplicates.

35. If your answers to Interrogatories No.5 and No.6 are in the affirmative state whether it is claimed that Esther J.Lichtmann has duplicates of the original copy books and/or manuscript diaries.

The entire set of originals is in safe keeping of Mrs Nettie S. Horch and Esther J. Lichtmann was only part transmitter (see also my reply to interrogatory No. 28).

36. If your answer to Interrogatory No.35 is in the affirmative, state whether you claim that Esther J.Lichtmann has a complete set of the duplicate originals of the copy book and/or manuscript diaries.

37. If your answer to Interrogatory No.35 is in the affirmative state whether it is claimed that the defendant Esther J.Lichtmann has only a part of the duplicate originals of the original copy books and/or manuscript diaries in her possession.

(as above).

38. If your answer to Interrogatory No.35 is in the affirmative describe in details exactly which duplicates of the original copy books and/or manuscript diaries are in her possession.

Miss Esther J.Lichtmann being only a transmitter should have no originals

and had no right to make or cause to be made copies nor duplicates.

39. If your answers given above indicate that the originals or part of the original copy books and/or manuscript diaries were given to Nettie S. Horch when were each or all of them so given?

In August 1930 before Mrs Horch's departure from India to New York I personally handed over to Mrs Horch two or three manuscript books for safe keeping, together withh all those previously given.

40. If your answers given above indicate that the originals or part of the original copy books and/or manuscript diaries were given to Nettie S. Horch, where and under what circumstances were each or all given to Nettie S. Horch?

This took place here in India. In 1930-31 Mrs Horch expressed many times her concern for the safety of all my original manuscript in the Museum Building and in 1931 she volunteered to keep all my manuscripts for me first in her appartment and later in a vault, which was taken in my name for their safe keeping, for which purpose I authorized one to be secured from the Chemical Bank in New York, what is confirmed in Mr. Horch's President's Réport of Oct.29,1932 signed by him. Later more original manuscript books were transmitted to Mrs Horch's safe keeping in 1934 by Prof. Roerich and 1931 and 1935 by Miss Esther J. Lichtmann. According to the Chemical Bank's statement the vault was discontinued by Mrs Horch (without my knowledge) on March 16th 1934. In 1934 Mrs Horch wrote me a letter, dated March 31 in which she stated:

"Dearest beloev Mother,

It is wonderful to have our beloved Father and George with us and to receive the wise Guidance and advices of our beloved Leader... I shall take the original books from upstairs into my apartment as was suggested...."

Thus my original manuscript books as above stated since March 1934 were in Mrs Horch's sole safe keeping.

41. If your answers given above indicate that the originals or part of the original copy books and/or manuscript diaries were given to Esther J. Lichtmann, when were each or all of them so given?

Part of the original manuscripts (several books) were given by me to Miss Esther J.Lichtmann in Sept.1931 and in Feb.1935, but only for transmittal, to be added to the others previously given, which were in safe keeping of Mrs Nettie S.Horch.

42. If your answers given above indicate that the originals or part of the original copy books and/or Manuscript diaries were given to Esther J. Lichtmann, where and under what circumstances were each or all given to Esther J.Lichtmann?

They were given to her by me personally in Naggar, when she left for the U.S.A. and on the definite understanding that they were to be keept safely on my behalf by Mrs N.Horch.

43. If your answers to Interrogatories No.5 and No.6 are in the affirmative

state whether it is claimed that Nettie S. Horch has duplicate of all or of part of the copy books and/or manuscript diaries.

Mrs Nettie Horch has the complete set of original manuscript books in Russian, covering the period from March 24,1920 to Feb.3,1935. These were supposed to be kept sealed and she had no right to make or cause to be made copies, duplicates, excerpts, etc.

44. If your answers to Interrogatory No.5 and No.6 are in the affirmative, state whether it is claimed that Esther J.Lichtmann has duplicates of all or of part of the copy books and/or manuscript diaries.

Miss Esther J.Lichtmann was only transmitter of parts of the abovementioned original manuscript books and had no right to make or cause to be made copies, duplicates, exceprts, etc. She was to hand the manuscript books over, sealed.

45. Were any of the copy books and/or manuscripts diaries which are the subject of this action, published?

No. Only parts and excerpts from the manuscripts books, at my own choice, & selection, were compiled and edited by myself, and were published in Russian. Later many of the published Russian books were translated into other languages.

46. If your answer to Interrogatory No.45 is in the affirmative, describe which of the copy books and/or manuscript diaries were published.

Not having before me the original manuscript books it is impossible to mark or indicate the actual passages selected.

47. If your answer to Interrogatory No.45 is in the affirmative state whether any of the copy books and/or manuscript diaries were wholly published.

48 If you answer to Interrogatory No.45 is in the affirmative, state whether just parts of the copy books and/or manuscript diaries were published.

Parts were published as stated in my reply No.45.

49. If your answer to Interrogatory No.45 is in the affirmative, describe which of the copy books and/or manuscript diaries were published, describing each of said copy books and/or manuscript diaries by their appearance, general content, dates covered and describe in particular the part or parts of such copy book and/or manuscript diary so published.

Not having before me the original manuscript bookss it is impossible to mark or indicate the actual published passages selected. But from the books submitted, the contents of the selected pages can be seen.

50. If your answer to Interrogatory No.45 is in the affirmative, state whether such publications of part or all of the copy books and/or manuscript

diaries were sold to the general public.

The published books were sold to the general public by the publishers as usual. The published parts form only a part of my original manuscript books.

51. I show you a lavendar book approximately 4-3/4" x 6-1/4" entitled "Hierarchy" bearing date on the outside cover "1931", copyrighted in 1933, printed in the United State of America and containing on the third page of the said book, the following "Signs of Agni Yoga" and ask you whether such book is a publication of any part of the copy books and/or manuscript diaries.

Yes.

52. If your answer to Interrogatory No.51 is in the affirmative, state whether such publication entitled "Hierarchy" is a part of one copy book and/or manuscript diary.

It is the American edition of the translation into English from the Russian edition, selected from several manuscript books.

53. If your answer to Interrogatory No.51 is in the affirmative, state whether such publication entitled "Hierarchy" contains parts of more than one copy book and/or manuscript diary in the same form.

Yes, it contains passages selected from several manuscript books.

The only pieces of jewellery I have received from Mrs Nettie S.Horch were a broach set with tiny pearls and a plain silver wrist watch. On my part I gave her a diamond ring, a diamond star broach and a carved amethyst pendent by Lalique. Her broach and wrist watch were received in 1923 in Paris and at the same time I gave her the pendent and broach. My diamond ring, which I had formerly given to her for safe keeping in 1923, was presented by me to her in 1928.

I never received any money or things of value from Mr. Horch for my personal use.

There are records of several historical prophecies and traditions which I came across in various countries and literature during my life.

The manuscripts do not contain any discussions whatsoever. The general content of the manuscript book has already been stated in answer No.79 and can be seen from the 4 books published in English translation, which have been submitted.

All were throughout in my own handwriting. The last copybook closes with my diary of Feb. 3rd 1935, is of slightly larger size, in blue cover, with gilt frame line on the front cover. The approximate size of the manuscript books is about 9x7 to 10x8 inches.

Lichtmann, that Mrs Horch considers the safe keeping of my manuscript books in the special place in the Museum's Building unsafe during the summer time and she, Mrs Horch, has suggested that all manuscript books should be taken over to her, Mrs Horch's appartment in the same building, in order to be transferred later to a safe or vault, taken in my name.

With this I agreed. Then handing over further manuscript books to Miss

Lichtmann before her departure in Sept. 1931 to be taken to New-York I told her that these were to be added to the others and were all to be kept as my property in safe keeping until I need them and I told her that they were to be kept sealed. Hiss Lichtmann promised to do so and to hand them over for such safe keeping on my behalf, to Ers Herch. Thus in 1931 all my manuscript books were taken over for safe keeping on my behalf, by Mrs Nettie S. Morch. A voult was then taken in my name for their safe keeping for which purpose I authorized one to be secured from the Chemical Bank in New-York. This was confirmed by Mr. Louis L. Horch in his " resident's Report" of Oct. 1932 signed by him. Further confirmation is found in the following two reports: From Mrs Nettie S. Horch, June 28, 1931 para 3: "before leaving New York for Moriah on June 14th, Ers Horch asked all Twustees to bring all letters, books and manuscripts of Prof. and Nme Roerich to the place gagreed upon, so that we can cable a reply to Kulu that this was done as requested And cable was received from New-York #1185/9 dated July 9th 1931: "DLT ROBRICH NACCAR - All manuscripts letters put safe - Since (Since Lichtmann). According to the Chemical Bank's statement rhe vault was discontinued by Mrs Horch (without my knowledge) on March 16th 1934. In 1934 Mrs Horch wrote me a letter, dated March 31. in Which she stated: "Dearest Beloved Mother, It is wonderful to have our beloeved Father and George with us and to receive the wise Guidance and advices of our beloved Leader I shall take the original books from upstairs into my appartment as was suggested ... " Thus my original menuscript books as above stated since Warch 1934 were in Mrs Horch were in Mrs Horch's sole safe. keeping. In Feb. 1935, when Miss Lichtmann again left from here for New York I again handed over to her further of my manuscript books which were to be added to those previously sent and were also to be kept by Mrs N. Horch in safe keeping on my behalf, and sealed, what Miss Lichtmann again promised to do. The total number is several dozens, and being in form of a diary, each subsequent manuscript book is by date a continuation of the previous book and there is no break in this continuity - thus the completeness of all manuscripts can be easily checked from beginning to end - from March 24,1920 to Feb.3,1935. The date of the first page of each manuscript book can be checked with the last date on the last page of the previous book. Besides there is in every manuscript book an inner front page on which the date of the beginning and end of that particular book is given and thus the uninterrupted continuity is easily established.

(b) 1) In 1925 Mr.V. Shibayev took my manuscript books dating from the 24th of March 1920 to Jan. 1925 on his way to Europe and posted them from Venice, Italy to Mew York to Mrs Sina Lichtmann, who at that time was custodian

2) in 1927 Mrs Sina Lichtmann took from me personally in Mongolia for same safe keeping on my behalf the next series of manuscript books dated up to spring 1927.

The resolution was passed and sent to New York that "All manuscripts and letters of Prof. and Mme Roerich must be kept in a special vault", and a request was made to New York to confirm this as soon as completed.

And confirmation of this was received in a report by Mrs Nettie S. Horch dated June 28,1931 and in a cable from New York dated July 9th.1931.

But the continuity of the manuscripts can be easily checked as on an inner front page pf every manuscript book there is the date of the beginning and end of that particular manuscript book and the uninterrupted continuity of all the manuscript books covers the period from March 24,1920 to Feb.3,1935.

5. Did you make or did you cause to be made any exact duplicates of all of the copy books and/or manuscript diaries which are the subject of this action?

No.

- 6. Did you make or cause to be made duplicates of any part of the copy books and/or manuscript diaries which are the subject of this action?

 Test some parts of the manuscripts had been selected by me and were typewritten for publication.

Miss Esther J. Lichtmann was twice the transmitter of some of the manuscript books for safe-keeping to New York. She was supposed to hand them over sealed to Mrs Nettie S. Horch for safe-keeping.

25. Is it claimed that the defendant Esther J.Lichtmann has all of the original copy books and/or manuscript diaries?

She was not supposed to be the custodian of these manuscripts, but only acted twice as transmitter.

Is it claimed that the defendant Esther J.Lichtmann has part of the original copy books and/or manuscript diaries?

(See above reply to question No.25).

She should not have any of my manuscripts in my handwriting in her possession, as she was only transmitter.

I claim that the entire set of manuscript books, which are subject of this action, should be in Mrs Nettie S. Horch's safe keeping and should be returned to me. If Mrs Horch has not received some of those manuscript books which Mrs Esther J. Lichtmann, adtransmitter, took over to her, then Mrss Esther J. Lichtman should return such to me.

29. If your answers above given indicate that you do not claim that Nettie S. Horch and Esther J. Lichtmann have all or any part of the original copy books and/or manuscript diaries, who, is it claimed by you, now possess part of the original copy books and/or manuscript diaries?

My above answer to question No.28, applies.

No, none of the other Trustees have any of these original manuscript books in my handwriting and all of them from March 24,1920 to Feb. 3,1935 must be with Mrs Nettie S. Horch.

Mrs Nettie S. Horch has the original manuscript books in my own hand-

writing. These were supposed to be kept sealed and not to be read, used or copied, etc. Since Mrs Horch does not know Russian, they were of not use to her. She had voluntarily undertaken to keep them safely for me, until I need them.

32. If your answer to Interrogatory No.31 is in the affirmative, state whether you claim that Nettie S. Horch has a complete set of the duplicate originals of the copy book and/or manuscript diaries.

She has the whole set in original.

33. If your answer to Interrogatory No.31 is in the affirmative, state whether it is claimed that the defendant Nettie S. Norch has only a part of the duplicate originals of the original copy books and/or manuscript diaries in her possession.

She has the whole unbroken set of the ORIGINALS in my handwriting in Russian from March 24,1920 to Feb. 3,1935.

34. If your answer to Interrogatory No.31 is in the affirmative, describe in detail exactly which duplicates of the original copy books and/or manuscript diaries are in her possession.

The entire set was described in my reply to direct interrogatory No.7 and it is claimed that she the set of ORIGINALS and not copies or duplicates.

The entire set of originals is in safe keeping of Mrs Nettie S. Horch and Esther J. Lichtmann was only part transmitter (see also my reply to interrogatory No. 28).

In August 1930 before Mrs Horch's departure from India to New York I personally handed over to Mrs Horch two or three manuscript books for safe keeping, together withh all those previously given.

40. If your answers given above indicate that the originals or part of the original copy books and/or manuscript diaries were given to Nettie S. Horch, where and under what circumstances were each or all given to Nettie S. Horch?

This took place here in India. In 1930-31 Mrs Horch expressed many times her concern for the safety of all my original manuscript in the Museum Building and in 1931 she volunteered to keep all my manuscripts for me first in her appartment and later in a vault, which was taken in my name for their safe keeping, for which purpose I authorized one to be secured from the Chemical Bank in New York, what is confirmed in Mr. Horch's President's Report of Oct. 29,1932 signed by him. Later more original manuscript books were transmitted to Mrs Horch's safe keeping in 1934 by Prof. Roerich and 1931 and 1935 by Miss Esther J. Lichtmann. According to the Chemical Bank's statement the vault was discontinued by Mrs Horch (without my knowledge) on March 16th 1934. In 1934 Mrs Horch wrote me a letter, dated March 31 in which she stated:

"Dearest beloev Mother, It is wonderful to have our beloved Father and George with us and to receive the wise Guidance and advices of our beloved Leader .. I shall take the original books from upstairs into my spartment as . was suggested "

Thus my original manuscript books as above stated since March 1934 were in Mrs Horch's sole safe keeping.

41. If your answers given above indicate that the originals or part of the original copy books and/or manuscript diaries were given to Esther J. Lichtmann, when were each or all of them so given?

Part of the original manuscripts (several books) were given by me to Miss Esther J. Lichtmann in Sept. 1931 and in Feb. 1935, but only for transmittal, to be added to the others previously given, which were in safe keeping of Mrs Nettie S. Horch.

49. If your answers given above indicate that the originals or part of the original copy books and or Manuscript diaries were given to Esther J. Lichtmann, where and under what circumstances were each or all given to Esther J.Lichtmann?

They were given to her by me personally in Naggar, when she left for the U.S.A. and on the definite understanding that they were to be keept safely on my behalf by Mrs N. Horch.

Mrs Nettie Horch has the complete set of original manuscript books in Russian, covering the period from March 24,1920 to Feb.3,1935. These were supposed to be kept sealed and she had no right to make or cause to be made copies, duplicates, excerpts, etc.
