-Annual Meeting of AGNI YOGA SOCIETY, INC. Wednesday, January 29, 1947 Present were: Sina Fosdick, Chairman I.Mouromtseff J. J. Weed Dudley Fosdick Ingeborg Fritschi 1. The meeting was called to order at 2:45 P.M. 2. Mr. J. J. Weed moved that same officers be re-elected for next year. The motion was seconded by Miss Fritschi and unanimously carried. 3. Treasurer's report was read by Dudley Fosdick, moved for acceptance by J. J. Weed. The motion was seconded by Miss Fritschi and unanimously carried. Also, Mr. Fosdick presented the form 990 financial report for the Government which was signed by Mr. Weed and Mr. Fosdick. 4. Minutes of November 6th, 1946 meeting were read, acceptance moved by Mr. Weed seconded by I. Mouromtseff and unanimously carried. 5. Report of current activities was read by the Chairman, as follows: "The total amount of members at present amounts to 108. Last season the amount of members were approximately 110: dropped out 22, a few gave various reasons such as financial inability and belonging to other organizations. However, we have gained quite a number of new members, some of whom were recommended through Mr. Jones. The monthly gatherings of Agni Yoga Associates continue: the last gathering was held on January 11, 1947. The average attendance is 18-20. "Fiery World", vol. 2 is being read and discussed at these gatherings. Early part of October 4 pages "Letters of the Mahatma" were mailed to the Agni Yoga Associates. "Fiery World", volume 2 is being sold very rapidly. "Aum" - entire edition has been exhausted. We added to our list of books "A Master of the Mountains" by Barnett D. Conlan and "Roerich" by R. Rentz which are sold respectively \$1.00 and 75¢ each. It has been decided to first sell all undamaged books and later make a decision about those which are damaged and shopworn". At this point in the reading Mr. Weed moved to prepare an inventory of all books with an estimated value, as assets of Agni Yoga Society. Miss Fritschi seconded it and it was unanimously carried. Mrs. Fosdick continued: "Thursday, from 1:00 to 5:00 P.M., during which time Miss Lou Jennings is in attendance, proves to be quite useful -a number of Associates usually come on that day to purchase the books and have a talk with Miss Jennings and whoever of the Directors is present.

"The library in the Agni Yoga Room is being brought into order. Miss Jennings is cataloging the books as they are assembled. This Library will be at the service of the Associates on Thursdays and on special evenings, by previous arrangement with those who cannot come during the day. There will be also a Russian section in the Library.

"Mrs. Campbell received several letters from Miss Frances Grant in which the latter claimed that she had expended certain sums of money for the storage of books and publications belonging to the former Roerich Museum Press and Roerich Museum. Inasmuch as Mrs. Campbell herself and Mr. and Mrs. Fosdick have spent considerably larger sums of money in handling the storage of these books and publications since 1938, and desiring to terminate all such controversies with Miss Grant, who has long since detached herself completely from Roerich Museum and its affiliated institutions, it was decided to offer Miss Grant the sum of \$150 in settlement of her claim for storage disbursements. After correspondence between Mrs. Campbell and Miss Grant, the latter agreed to accept the sum of \$150, relinquishing forever any claims on any books, assets and publications of the former Roerich Museum Press, Roerich Museum, Agni Yoga Publications or Agni Yoga Press. Agni Yoga Society Inc., assuming responsibility for this payment to Miss Frances Grant, sent a check to Mrs. Campbell for \$150.00 on January 24. 1947".

Miss Fritschi protested that this does not exactly describe what took place, and also that Mrs. Campbell wishes to pay the sum of \$150. herself. After discussion it was decided that this matter be deferred until the next meeting, at which time Mrs. Campbell might present her own considerations.

- 6. The Chairman informed the Board that a draft of an Agni Yoga pamphlet has been prepared by her and Mr. Fosdick, sent to Prof. and Mme. Roerich and approved by them. Copies will be made of it and sent to Directors prior to printing.
- 7. Having no further business at hand, the meeting adjourned at 3:55 P.M.

Meeting of AGNI YOUA SOCIETY, INC. Wednesday, May 28,1947 Present were: Sina Posdick, Chairman Turene Posdick, Proxy J. J. Weed Andley Posdick Mrs. Katherine Campbell Miss Ingeborg Fritschi Col. I. Mourombseff 1. The meeting was called to order at 3:30 P.M. Minutes of January 29, 1947 meeting were read and approved as read. 2. Miss Fritschi reported that the inventory of books which was to be prepared for this meeting has not yet been made by her due to weather conditions in Connecticut, since the books are stored in a barn. Miss Fritschi plans to complete the inventory during the summer and also to set, upon consultation with the other directors, the approximate value on damaged books as well as on the other books. Also, Eiss Fritschi has promised to send in a report of books sold in Connecticut. 4. The 8 monthly meetings of Agni Yoga Associates, which ended with the last one in May, were very satisfactory as to the interest shown and attendance. There usually were 19 or 20 members at these meetings. Mr. Need expressed his gratification at the results since he was present at many of the mostings and witnessed the sincere interest of the members present. The Chairman reported about the Thursdays from 1:00 to 5:00 P.M. 5. which were held open for Apri Yoga Associates and their friends during the winter. She suggested to discontinue them since they tend to become social events, and besides Miss Jennings was ailing during the last few months and will not be able to continue. Mr. weed proposed to take up the question of these weekly open days in the fall. A discussion arcse as to whother instead of daytime to chose an evening for those members who would be interested to visit the library. In connection with this thought, it was proposed to consider Wednesday from 6:00 to 8:00 P.M., asking Mr. Houston and Miss Peter to alternate, if they would be free to give their time on that day. 6. Er. Sikorski not being usually free for the post of Librarian, due to his occupation, it was decided not to elect a new librarian. but invite volunteers for one evening a week, such as suggested above, but without, however, any title being given to them. 7. The chairman reported that payment of the grant of \$200.00 to Miss Lou Jennings was completed during the summer. Miss Jennings was present Thursdays and began work on compilation of Psychic Energy. In her recent letter acknowledging the receipt of a \$100.00 check, (second half of grant) Miss Jennings mentioned that she hopes to return the entire sum of \$200.00 sometime in the future to Agni Yoga Society "to fill some need".

3. The Chairman reported that the Associate members at present number 111, and that since January 1, 1947, 285 books were sold, including 61 "Fiery World", vol. 2. Also, that we have mailed out three sendings of certain pages of the "Letters of the Mahatma" to Agni Yoga Associates.

9. Regarding the point in the previous meeting which had to do with the

9. Regarding the point in the previous meeting which had to do with the correspondence between Mrs. Campbell and Miss Frances Grant, in the course of which Mrs. Campbell sent a check for \$150.00 on January 24, 1947 to Miss Grant in settlement of Miss Grant's claim for reimbursement of storage on books paid by her in the past, Mrs. Campbell suggested that in order to clear up our record of the transaction the actual correspondence, copies of which she had brought to this meeting, be made a part of these minutes.

In one of the letters of this correspondence, copy attached hereto, Miss Grant states that she is ready to accept the \$150 and consider the books the property of Mrs. Campbell, but perhaps she has not legally relinquished all rights to future claims as mentioned in the meeting of January 29th.

Further, Mrs. Campbell stated that she would like to regard this \$150.00 check to Miss Grant, which Agni Yoga Society offered, duty bound, to pay, as her personal contribution to the Society. The Chairman moved that Mrs. Campbell be thanked for her donation.

Mrs. Campbell further stated that the Agni Yoga Co. which was formed a number of years ago still stands. Mrs. Fosdick reminded Mrs. Campbell that Mrs. Bettie Horch in 1935 informed Mrs. Fosdick in writing, that she relinquished all her connection with Agni Yoga Co. as of that date and officially turned over all the books and assets to Mrs. Fosdick (Sina Lichtmann). Mrs. Campbell felt, however, that Mrs. Horch spoke for herself only but not for other partners, and that Miss Grant could still make claims if she wants to, on the books of Agni Yoga. The Chairman wondered whether it would not be wise to inquire whether Agni Yoga Co. legally has any rights at present. This consideration was supported by Col. Mouromtseff. Mrs. Campbell felt that perhaps it would be best to let the whole matter rest and not start any interrogation at present. Mr. Weed was also of the same opinion, reminding those present that his original idea was to make Miss Grant relinquish any claims of hers on all books, before Mrs. Campbell sent her a check, but since the check was sent prior to any such demand made to Miss Grant and nothing seems to threaten Agni Yoga Society now, it is better to let the matter rest as is. Mrs. Campbell at this point felt that anything which might arise in future will be between her and Miss Grant.

- 10. The Chairman offered to those present a copy of the prepared Agni Yoga Society pamphlet to be approved prior to having it sent to the printer. The pamphlet was unanimously approved and Mr. Weed was asked to kindly send it to his printer, ordering 500 copies for which Agni Yoga Society will be obligated to pay. A separate sheet, listing books and prices, can be placed in the folder when mailing.
- 11. The Chairman reported that work will continue on preparation of "Fiery World", volume 3.
- 12. Having no further business, the meeting adjourned at 4:15 P.M.

The fifth meeting of the season/opened by Mrs. Fosdick/dedicated it, as has been customary on this date, to the memory of Prof. Roerich.

Mrs. Fosdick spoke of Prof. Roerich's universality, synthesis and practical idealism, which made him a leader of men besides his being an Envoy of the Hierarchy. She read, from Prof. Roerich's book, HIMAVAT, portions from his essays "Combating Ignorance" and "The Beautiful Victory". Both these essays reveal his lofty appeals to culture and cooperation - ideals which permeated his life and thought.

Mrs. Tussupoff read a few paragraphs from INFINITY, revealing Prof. Roerich as the Agni Yogi and his link with the cosmic processes and manifestations.
