- 1. Gene Fosdick was unanimously appointed Chairman, and the meeting was called to order.
- 2. Minutes of the first meeting of the proposed Corporation were read and, with ammendments approved.
- 3. By-laws of the Corporation prepared by Gene Fosdick which had been previously discussed were presented and adopted.
- 4. Proofs of the first publication CULTURE were presented as were also proofs of stationery and Membership Certificates. After several changes all were approved.
- 5. A financial prospectus, prepared by Gene Fosdick, was presente ed and discussed.
- 6. Dudley Fosdick submitted a text to be added at the conclusion of the first publication CULTURE which was approved. Gene Fosdick submitted a form for membership application which was also approved. Gene Fosdick was then commissioned to prepare a form combining these two into a pamphlet for publication.
- 7. The possibility of an art gallery and the importation of paintings and objects of art was discussed.
- 8. A text for the publishers preface to be used in CULTURE was prepared and presented by Gene Fosdick, and was approved.
- 9. Having no further business at hand, the meeting was adjourned.

- 5. It was also announced that the MONOGRAPH together with the following books had been placed on sale on a consignment basis at the Meridian Bookshop, Inc., 134 Monument Circle, Indianapolis, Indiana: Pillars of Life, Messenger Man The Triune God, Gothe, Elame in Chalice, Foundations of Buddhism, Realm of Light, Heart of Asia, Union of Souls, Wit and Wisdom of India, Roerich.
- 6. A communication from the Teasury Department was read which announced that Flamma's return (Capitol Stock Tax) was being closed on the records of that Department for the year ended June 1938. No tax being due.
- 2. Commendation for the efforts of the friends of Flamma in New York were expressed in connection with receipt of news of their work for the advancement of Culture.
- 8. There being no further business on hand the meeting was adjourned.
