- 2. This corporation is organized for the following cultural and benevolent purposes, to wit:
 - A. To advance the cause of peace through culture among nations, to encourage the adoption of the Roerich Pact, and the Roerich Banner of Peace for use in the protection and preservations of works of art and the cultural treasures of the world; to catalog the cultural treasures of the world; ti secure the cooperation of all individuals. without distinction of race, creed or class, and educational, scientific, and religious institutions, institutions of art and other bodies formed to advance the cause of peace, in the work of this organization; and to disseminate knowledge and information concerning the activities of this organization and its aim. The corporation is empowered to use for these ends such methods, agencies and means as from time to time shall seem expedient to its directors, or be found appropriate therefor.

- B. This corporation shall have the power to take receive and acquire by bequest, devise, gifts, purchase, lease or otherwise, either absolutely or in trust, for any of its purposes, and to hold any property, real or personal, without limitations as to amount or value, except such limitations, if any, as shall be imposed by the laws of the State of New York; to convey such property, and to invest and reinvest any principal, and deal with and expend the principal and income of the corporation in such manner aw in the hydgement of its directors will best promote its aforesaid objects, or

Upon the suggestion of Esther J. Lichtmann the motion duly made, seconded and unanimously passed IT WAS RESOLVED: To appoint an Advisory Council to which prominent leaders in all walks of life may be elected, whose function it will be to render advice and assistance to the Executive Council of the World League of Culture.

The following were suggested for consideration as members of the Advisory Council: Hendrick Van Loon, Ruth St. Denis, Dr. H. Overstreet G.G. Battle, Morris L. Ernst, Wayman Adams, F.L. Wright, A.V. Tack.

Upon motion duly made, seconded and unanimously passed IT WAS RESOLVED: That the Roerich Museum and its separate departments in addition to all branches of the Roerich Museum, Roerich Society and associated institutions become automatically members of the World League of Culture.

A general discussion regarding classes of membership was brought up, but decision was deferred. The meeting was then adjourned.

CONSTITUTION

Article 1.

Name

The name of this organization shall be: WORLD LEAGUE OF CULTURE INC. American Section.

Article II.

Objects.

The objects of the organization shall be:

To advance the cause of peace through culture among nations, to encourage the adoption of the Roerich Pact, and the Roerich Banner of Peace for use in the protection and preservations of works of art and the cultural treasures of the world; to catalog the cultural treasures of the world; to secure the cooperation of all individuals, without distinction of race, creed or class, and educational, scientific and religious institutions, institutions of art and other bodies formed to advance the cause of peace, in the work of this organization; and to disseminate knowledge and information concerning the activities of this organization and its aims.

Article III

Membership

Section 1. Individuals or organizations in sympathy with its aims are eligible for membership in this League.

Section 2. Organizations, societies and other collectives join the League on autonomous principles, not losing their identity or name, but for the mutual help in various spheres of communion.

Section 3. Prospective members and or ganizations must be proposed by a member of the League in good standing and must be accompanied by an application stating the class of membership desired, accompanied with a check for one years dues. Such applications will be submitted to the Executive Council and a Majority vote will be necessary for final acceptance.

Section 4. The term of Membership will be for one year from date of acceptance by the League. Membership accepted on or before the fifteenth of any month will date from the first of that month, and if accepted after the fifteenth of any month will date from the first of the following month.

Article IV

Governing Bodies

Section 1 The governing power of this League shall be vested in an Executive Council, and the officers.

Section 2. The Executive Council shall consist of the Directors who founded the League, the officers and others elected to that Body. The Executive Council shall have the authority to conduct the business of the League, to order Disbursements and Investments of the funds of the League.

Section 3.

Article V

Officers

The Officers shall be a President, one or more Vice-Presidents, a Secretary and a Treasurer. They shall be elected for a period of one year as shall be provided for in the By-Laws and shall hold office until their successors are elected.

Article VI

Section 1. The Executive Council shall hold its regular meeting on the first Monday of each month, with the exception of July, August and September, unless otherwise designated by the Ex. Council.

Section 2. Seven members shall constitute a quorum for the transaction of business.

Article VII

Amendments.

This constitution may be amended by a two thirds vote of the Executive Council provided the proposed amendment has been presented to the Council, in writing, at a meeting not less than four weeks previous.

BY - LAWS

Article 1

Election of Officers

Section 1. The Officers shall be elected by a majority vote of the Executive Council.

Section 2. The election shall take place every year at its November meeting, which shall constitute the annual meeting of the officers.

Section 3. The nominating committee shall present a slate at the monthly meeting preceeding the annual meeting of the officers.

Section 4. Election shall be by ballot.

Article II

Duty of Officers

Section 1. President. The President shall preside at all meetings at which he is present.

Section 2. Vice-Presidents. The Vice-Presidents shall preside at all meetings in the absence of the President. The Vice-President shall succeed each other in the order in which they were elected.

Section 3. Secretary. The Secretary shall keep the records of the League and shall record all Minutes in a book to be kept for that purpose. The Secretary shall also see that notices of all meetings be sent to the Executive Council. The Secretary shall conduct all correspondence relating to the organization. The Secretary shall keep a register of the members of the organization.

Section 4. Treasurer. All moneys payable to the organization shall be paid to the Treasurer of the organization. All moneys payable by the organization shall be paid by checks signed by the Treasurer, and countersigned by one of the officers. He shall report at each meeting of the organization the condition of the treasury.

Article III

The membership of the League shall be divided into the following classes:

Members of the Advisory Council. Members of the Advisory Council shall be elected by a majority vote of the Executive Council of the League in recognition for valuable services rendered to this organization, or for distinction in their fields of endeavor. These shall be granted all privileges of memberships and shall be exempt from all dues.

Corresponding Member. A corresponding member shall be a member regularly elected for the purpose of promoting the ideals of the League. Such member shall be granted all priviliges of the League and shall be exempt from annual fees.

Annual Membershop for Individuals. An annual individual member is one who contributes \$1,00 annually to the support of the League.

Annual Membership for Organizations. An annual organization member is an organization which contributes \$3,00 annually to the support of the League

Article XV

Meetings

Section 1 The regular meetings of the Executive Council shall be attended only by the Executive Council of the League.

Section 2. A special meeting of the Executive Council may be called at any time at the request of three members, with due notice given.

Section 3. Should the Executive Council of the League deem it necessary to call a special meeting from any classes of membership, they may do so upon a majority vote.

Section 4. All organizations which have joined the League have the privilege to send their representative to special meetings called by the Council of the League.

Section 5. For the discussion of questions of general importance partial or general conventions can be summoned, to which can be invited according to the resolution of the local council institutions as well as individuals who did not enter into the League, but who can help in cause of Culture through their knowledge.

Article VI

Vacancies

Section 1. In case of the death or resignation of any one of the officers, his successor shall be elected by a majority vote of the Executive Council.

Article VI

Standing Committees

Section 1. The activities of the League shall be conducted by the following standing committees.

- (a) Membership Committee
- (b) Nominating Committee
- (c) And such other committees as the Ex. Council may create.

Article VIII

Amendments

The By-Laws may be amended only at a special meeting called for that purpose. Notice of such meeting must be sent four weeks previous stating the proposed amendment in the notice and must be approved by two-thirds vote of the members present.

WORLD LEAGUE OF CULTURE

The World Learne of Culture, founded by Nicholas Roerich is an International Federation aiming to unite all scientific, artistic, literary, educational, industrial and financial organizations, as well as other institutions, societies and individuals working along any fields of cultural endeavor. It shall be dedicated to advancing and safeguarding the world's cultural ideals and traditions and fostering world-cooperation. The World League of Culture shall have no distinction of creed or race and shall be composed of institutions, societies and individuals devoted to cultural work in all fields as well as to international intercourse and human progress, aiming towards the New Era.

It shall be the purpose of the World League of Culture to foster, as a body or through its individual members, such movements as, in accordance with its aims, shall serve the ideals of international reciprocity and tolerance. The World League of Culture shall dedicate itself to the cause of Peace through Culture and to this end it is committed to safeguarding and advancing the creations of human genius and promoting the cause of general well-being. As expressed in the words of Nicholas Roerich, "Culture and Peace are the most sacred goals of humanity. Out of the temples and shrines of spirit, out of the light-radiating centers must thunder ceaselessly the world-wide call, eliminating wer and creating the new lofty traditions of veneration for the real cultural treasures. The time is short. We can lose neither a day nor an hour. Let us, under the Banner of Peace, proceed towards one supreme light, in powerful unity as the World League of Culture."

THE AIMS

1. All organizations, societies and individuals working along any fields of cultural endeavor and in sympathy with its aims, may enroll in the World League of Culture.

2. Organizations, societies and other collective bodies joining the World League of Culture do so for mutual action in various fields and retain their autonomous standing without losing their indiviual identity or name. These organizations are eligible to nominate their delegates to the League Councils which shall be formed in each country.

3. The World League of Culture shall include all cultural activities in the fields of Peace; Science; Arts; Education; Social Welfare and mat maternity welfare; Religious and philosophic activities; Labor and handcraft; Industrial Cooperation; Protection and Security; Agriculture and Building; Health Protection.

4. The World League of Culture aims to hold periodic conventions when delegates of its various national councils as well as other invited cultural representatives may meet to deliberate and act upon measures aiming to the advancement and protection of culture.

5. The World League of Culture shall work for the world-wide adoption of the Roerich Peace Pact, so that akk monuments and cites representative of creative traditions, such as museums, universities, cathedrals, schools, libraries, etc. shall be marked by the Roerich Banner of Peace in token of their inviolability and for their protection against destruction during all times. To the accoplishment of this aim, the World eague of Culture shall sponsor the cataloguing, through photographs records, descriptive writings, sketches, etc. of the cultural treasures of the world.

6. The World League of Culture will aim to establish publications, periodicals, etc. to spread knowledge of kkix its work and to encourage all efforts towards cultural intercourse and cooperation.

Membership in the American Section of the World League of Culture shall be divided into Individual Membership with an annual fee of \$1.00, and Organization Membership with an annual fee of \$3.00.

Minutes of the 1st Meeting, at Urusvati, Feb.8, 1933.

The undersigned were present.

- 1) Prof.de Roerich opened the Meeting with the following: "With these Minutes we open separate proceedings of the World League of Culture, Himalayan Section. As I have already written to the American Section, we have at present before us a period of accumulation. Before our groups of the World League of Culture can manifest themselves publicly, they must patiently and untiringly gather new forces, remembering that the conditions of strategy, both disciplinary and spiritual, are essentially similar. Our work cannot spread so quickly, because it is in many countries and one turn over of letters takes no less than two months. But we know how urgently work in the field of culture is required and we know that many new co-workers will respond to our calls and will join our peaceful host, which by its peacefulness, friendliness, patience, untiring cognizance and hearty co-operation will overcome all difficulties. Thus with all care, without negation and with the broadest outlook for expression of individuality and c reativeness - let us ascend along the path of goodwill!"
- 2) The Minutes of the 3rd Meeting of the World League of Culture, American Section, of Dec.13th were read. We were glad to hear that Prof.Radosavljevitch and the Dr.Campbell, Director of the Irish Foundation have joined as Vice-Presidents.
- 3) The constitution of the League (American Section), By-laws and draft of Leaflet were read. Although according to the attached note this was not yet the final draft of the Constitution, but we were glad to see how the "Peace through Culture among Nations" is emphasized and how thus closest harmony and co-operation is established with the American Committee of the Peace Pact & Banner. Equally well are underlined all cultural activities and co-operation in vast educational fields on an international scale.
- 4) A letter dated Jan.9th from the World League of Culture American Section, signed by Mrs Campbell and Miss Fritschie was read.
 - 5) We suggest to spread the ideals of the World League of Culture amongst young boys and girls in colleges, etc. The episode mentioned in Miss F.R. Grant's letter of the young boy Ackerman, shows that similar youngsters could spread the ideas of Culture amongst their friends, and form small nuclei of the World League of Culture amongst themselves.
 - 6) Referring para 9, of of Minutes #3, the insignia is not to be made until Prof.de Roerich's arrival, as before stated.
 - 7) With regard to the leaflet on aims, Prof.de Roerich requests, since he has been elected the Supreme President of the World League of Culture, to omit from the constitution and elsewhere the mentioning and title of "Founder" leaving only his denomination as Supreme President.

8) The World League of Culture and the World Council are quite separate bodies and the American Section can very well work representing the World League of Culture.

Minutes of the 1st Heeting, at Urusvati, Feb.8,1933.

The undersigned were present.

- 1) Prof.de Roerich opened the Meeting with the following: "With these Minutes we open separate proceedings of the World League of Culture, Himalayan Section. As I have already written to the American Section, we have at present before us a period of accumulation. Before our groups of the World League of Culture can manifest themselves publicly, they must patiently and untiringly gather new forces, remembering that the conditions of strategy, both disciplinary and spiritual, are essentially similar. Our work cannot spread so quickly, because it is in many countries and one turn over of letters takes no less than two months. But we know how urgently work in the field of culture is required and we know that many new co-workers will respond to our calls and will join our peaceful host, which by its peacefulness, friendliness, patience, untiring cognizance and hearty co-operation will overcome all difficulties. Thus with all care, without negation and with the broadest outlook for expression of individuality and c reativeness - let us ascend along the path of goodwill!
- 2) The Minutes of the 3rd Meeting of the World League of Culture, American Section, of Dec.13th were read. We were glad to hear that Prof.Radosavljevitch and the Dr.Campbell, Director of the Irish Foundation have joined as Vice-Presidents.
- 3) The constitution of the League (American Section), By-laws and draft of Leaflet were read. Although according to the attached note this was not yet the final draft of the Constitution, but we were glad to see how the "Peace through Culture among Nations" is emphasized and how thus closest harmony and co-operation is established with the American Committee of the Peace Pact & Banner. Equally well are underlined all cultural activities and co-operation in vast educational fields on an international scale.
- 4) A letter dated Jan. 9th from the World League of Culture American Section, signed by Mrs Campbell and Miss Fritschie was read.
 - 5) We suggest to spread the ideals of the World League of Culture amongst young boys and girls in colleges, etc. The episode mentioned in Miss F.R. Grant's letter of the young boy Ackerman, shows that similar youngsters could spread the ideas of Culture amongst their friends, and form small nuclei of the World League of Culture amongst themselves.
 - 6) Referring para 9, of of Minutes #3, the insignia is not to be made until Prof.de Roerich's arrival, as before stated.

The undersigned were present.

1) Prof.de Roerich read his current Address to the World League of Culture, which is herewith enclosed.

Prof.de Roerich then pointed out that the previous article "Exchange" should also be read at the World League of Culture's Meeting, because all such co-operation in cultural undertakings is fully within the interests of the League. And even during its preliminary preparatory period, if there is a possibility, a useful activity of co-operation should always be maintained.

- 2) The Minutes of the 4th Meeting of the World League of Culture, of Jan.3rd 1933, NY, were read. As regards para 5, the making of the insignia should be left until Prof.de Roerich's arrival.
- 3) The Academy of Creative Arts' letter of July 5th 1932, of which a copy was received with abovementioned minutes, was read (re: their expression of enthusiastic adherence to the World League of Culture).
- 4) We shall be glad to know, how responded to their election as members of the World League of Culture, others of our Societies, like the Spinoza Center, etc. etc. in America. We remember such acknowledgments from the French Roerich Society in New-York.
- 5) When coming across people who do not understand the real meaning of the word "Culture" it is good to refer them to such books as "The Evolution of Culture" by Henry Proctor, F.R.S.L., F.L.L.C., F.I.A.Sc., M.R.A.S., Associate of the Victorian Institute & Philosophical Society of Great Britain (London 1913), and also Dr. James Cousins (Dr of Literature) "Salvaging Civilization by Culture", Young Builder, Karachi, April 1932.

H. Koelich Bluter. Minutes of the 3rd Meeting, held at Urusvati, June 21st, 1933.

The undersgned were present.

- 1) Prof.de Roerich acknowledges with thanks receipt of the letter from the World League of Culture, dated May 21st.
- 2) We have received the revised Constitution but find that the aims are not included as fully, as previously sent to us, where the foundation and SIX points of aims covered a wide field of general cultural activities. Now in the revised consititution we see the sole aim as Peace, whereas only Culture can lead to Peace, and this paragraps of the revised Constitution would therefore more appropriately suit a constitution of the Banner of Peace Committee. Of course the paragraph as it now stands may fully enter the general aims of the League of Culture, as its fifth para as before but it does not represent the aims of the WLC fully, as they were before expressed in Six Paras. Thus in order not to meet a certain objection because of the one-sidedness of aims, the objects should be enlarged into six paragraphs as expressed before in the leaflet for the World League of Culture.
- 3) Minutes #4 of Jan.3rd were received with this mail, but as we have acknowledged them already on March 22nd, we fail to see why they were sent again.
- . 4) We expect that the World League of Culture shall actively participate in the promotion of the Peace Banner Convention in Washington.
- 5) The publications of the Roerich Museum Press as well as other publications of Prof.de Roerich in other publicating companies, as well as the book of Duvernois, should be used by the World League of Culture as useful material for spreading the ideals of Culture.
