Dear Sir:

I have received your letter of December 24 asking me to transmit to my Government the information that an international depositary for plenary powers on the Roerich Pact is with the PERMANENT COMMITTEE FOR THE ADVAN EMENT OF THE ADOPTION OF THE ROERICH PACT AND BANNER OF PEACE, at the address of said Committee at Roerich Museum, 310 Riverside Drive, New York City; that the said Committee will retain the instrument of the Roerich Pact open to all nations for ratification, and will administer all negotiations relative to the same; that in accordance with the Resolution passed unanimously at the Third International Convention, the manner of ratification of the Roerich Pact has been extended to permit ratification: (a) by unilateral action through procla-mation of the executive of any government, (b) by bilateral action through international agreements, or (c) by multilateral action through declaration of international conferences; that by a unanimous Resolution of the Seventh International Conference of American States held at Montevideo, Uruguay, in December, 1933, the "Roerich Fact" was recommended for adoption to all of the American Governments; and that a number of these governments, including the United States, have already signified their adherence to the Pact, and the consummation of the Montevideo Resolution by the remaining governments is anticipated on or before April 14, 1935.

In reply I wish to state that I shall not fail to transmit to my Government the above information.

Dear Mr. Horch:

I take the liberty of addressing you because I am deeply interested in the aim and purpose of the Rorich Museum.

I have read the text of the pact to be know as the Roerich Pact, signed by ourselves and twenty other American Republics, here in Washington, on April the fifteenth.

There is no doubt that such aims are to be highly encouraged and will do much to promote understanding and good will between nations, particularly of this hemisphere.

But on reading the wording of the pact, I was deeply disappointed in finding the title "religious" excluded. Scientific, artistic, educational and cultural institutions and monuments are specifically named: but religious monuments and institutions are not named.

This is the more surprising because I find that in his speech of that day, the Panaman Minister, Senor Alfaro mentions religious monuments and quotes the General Act of the Berlin Conference on African Trade (1885), as including religious institutions. This Act, he further declared, was confirmed by the Treaty of St. Germain, 1919, and specifically mentioned religious institutions. Article 27 of the second Hague Convention (1907) specifically mentions "buildings dedicated to religion."

In your own speech of that day, you define the intention of Nicholas Roerich in establishing the Roerich Museum - "to preserve the treasures of art. science and religion."

 I_n his speech of that day, Secretary Wallace specifically spoke of the human heart's devotion to religion.

Would you kindly give your consideration to the work of having religious definitely and specifically inserted in Article I of the Rorrich Pact.

We will, of course, receive many inquiries from the countries of South America, and we know antecendently that much surprise and disappointment will be expressed over the omission of "religious". And would not the flag, planned by the Roerich Pact, the Banner of Peace, have a fuller and more comprehensive meaning if "religious" were included?
