Dear Sirs,

Your letter of March 17th 1930, addressed to Mr.J.F. Artemieff, concerning a claim of Mr.A.A.Golubin against the Roerich Museum has been handed to me for reply.

I regret that I am compelled to differ with the statement made by you in your letter of above date and the proof of the fact that Mr. Golubin has not been paid is contained in the series of documents, copies of which Mr.Artemieff sent to you.

There is no dispute but that Mr.A.Zykoff received a remittance from Mr.Kardashevsky for the sum of \$963.74, and this money was turned over to a man by the name of Mashkovtzeff and that Mashkovtzeff did not pay the sum of \$600.00 due to Mr.Golubin for his services and the proof is in the statement signed by N.Mashkovtzeff under date of July 9th 1928 which specifically states that Golubin had not been paid. Shortly after this date Mr.Mashkovtzeff disappeared and took whatever money there was left with him and his whereabouts is now unknown. You also received a copy of a Power of Attorney of Mr.Golubin signed by Mr.Kardashevsky authorizing Golubin to secure \$600.00 from Mashkovtzeff and also a copy of a letter dated October 25th 1928 confirming the fact of the failure of the failure of Mashkovtzeff to pay Mr.Golubin, and these original documents are now in my hands.

In view of the foregoing, unless you have a signed receipt from Mr.Golubin, it is difficult for me to understand your statement that he has been paid in full. You are well aware that only payment to the person himself will constitute a payment, and if your client paid the money to someone else for the purpose of paying my client and he failed to do so, your client is not released.

I will thank you to take the trouble of going over the copies of the documents sent you, which will prove the statements contained in this letter and I trust that you will advise your client that unless a receipt such as I have mentioned is in his possession, to let me have a remittance for \$600.00 Mex to liquidate the claim.

Please let me hear from you at your early convenience and oblige.
