Dear Dr. Bressman.

We are in receipt of your two letters of October 22nd and of December 30th, 1934. The first letter was reforwarded here from

Harbin, hence the delay in acknowledging it.

Following receipt of your radio of Jan. 17th we at once started inquiries about the first sending of material scheduled to leave Harbin about the end of November last, and have sent you the following cable: - " Have investigated November sending stop collection safe writing letter stop part herbarium sent January nineteenth stop shall cable dates further sendings. Roerich ". It appears that the first sending containing seeds and some herbarium specimens was delayed by our botanist who required this material for comparative purposes. He had sent some specimens to the Museum of the Mission de Sienshien in Tientsin for identification, and the absence of reply from the Museum caused some delay. He notified us of the delay by letter which apparently went astray as there were no postal communications between China and Manchuria at that time, and letters had to be sent through travellers. However since Jan. 10th, 1935, postal communications between China and Manchuria have been resumed, and we now received notification that the first sending instead of November was sent on Jan. 19th through the U.S. Consulate in Harbin. I am enclosing a list of forage peadts'seeds, as well as a list of herbarium specimens included in the sending of Jan. 19th. The herbarium of medicinal plants specimens will be forwarded in a few days, and I shall let you know by cable the dates of future sendings.

Our letter of Dec. 24th addressed to the Secretary contained the preliminary report on our botanical fieldwork in North Manchuria.

Dear Dr. Bressman:

We are in receipt of your letter of the I4th ultimo enclosing lists of materials collected by the other members of the Asiatic Expedition.

The second sending was despatched through the Consulate on the 2nd instant, and I am enclosing the lists of material contained in the second sending (systematic herbatium and 78 packages containing medicinal plants speciences collected from medicine men in North Manchuria). Further sendings of herbatium material will follow. Our first sending of Jan. 19th contained some seed material. You will notice that only those seeds were gathered which were considered useful for introduction as fodder plants for arid steppe areas. Enclosed please find "Pre-audit Difference Statements" numbers 15827,15828,15829 and 15830, which refer to your and Professor Regriches expenses vouchers of October and November. The four expense vouchers totalled \$ 1,857.40, and the Comptroller General certified \$ 1347.13, leaving a difference of \$ 510.27.

These "Pre-audit Difference Statements" are similar to those forwarded to you in January for expense accounts previously submitted. As indicated at that time, you may prepare and present new voucners covering any or all of the \$510.27 not certified by the Comptroller General. For example, I note on the "Pre-audit Difference Statement" covering Bureau voucher No.15830 that there is a sub-voucher No.7, October 28,1934, for various items including two tents. If these tents were necessary for the success of the expedition, and / or to protect valuable Government property, and / or used by more than one individual and, therefore, not personal expense, I am of the opinion that these items may be properly rsubmitted together with a statement giving the exact conditions and the reasons why the equipment was purchased. Also, I feel that any other similar items may be properly resubmitted if the items are not personal but are necessary for the proper conduct of the expedition.

In the future I suggest that articles such as tents which apparently are for the expedition be not submitted on a sub-voucher with an item such as shoes which apparently are for one individual and personal. Also, I suggest that you prepare a signed statement for each sub-vougher which may be questioned so that all facts may be at hand when a voucher is originally presented.

You will note that at the bottom of the "Pre-audit Difference Statement" there is a note as follows: (if the above items are resubmitted in a subsequent voucher, this Pre-audit Difference Statement must be attached thereto). Therefore, if any of these items are resubmitted, be sure to attach the proper "Pre-audit Difference Statement" as well as your signed statement as to the exact use and need of the items purchased.

This is to acknowledge receipt of your letter of January 28 and the enclosed list of forage plant seeds and herbarium specimens included in the shipment of January 19. As yet this shipment has not been received, but we are hoping that it will be here in the very near future. Several of the seeds appear to be of real interest and value, particularly the Agropyrum pseudo-agropyrum. We note that the number of different forage seeds is somewhat limited and the the herbarium is rather extensive. I am wondering if it would not be advisable in this year's collections to extend the number of forage plant seeds rather than the herbarium specimens. Both are of real interest and value, but I feel that we must be primarily interested in the seeds for propagation.

For your information and help, I have had various workers in forage crops make some suggestions as to material that would be of value. I am enclosing these suggestions in the attached memorandum, which I hope may be of some value to you. It is not intended in any way that all these materials are to be collected, but I desire to be of assistance and offer this list for whatever use you can make of it.

Dear Dr. Bressman:

Please find enclosed our Vouchers for the period of Feb. I-28th, I935 with covering bills and receipts. Since sending our Vouchers covering the months of December and January, we have received additional sums from the Department (Prof. de Roerich - US\$ 1935.67; myself - US\$ II55.86) so that the amounts kept in personal possession are US\$ 2922.47 and US\$ 2863.71 respectively.

Under separate cover I am sending the required explanations about items listed on previous Vouchers. I hope you will find them adequate.

We have completed our preparations and hope to leave in a few days for the interior. Our future address will be c/o Rev. Carl G. Soederbom, M.P.Mission, Kalgan, N.China. Letters sent c/o Hongkong Shanghai Bank, Peiping, will be reforwarded. Since the Legation required an authorization from the Department to accept our collections for shipment, we were obliged to send you a cable, as per copy enclosed.

Yesterday we received your radio for which please accept our best thanks. Four packages containing pharmacological collections and covering data were handed over to the Legation authorities to-day (Copy of receipt enclosed). The four packages contain the following material:-

- I) One case with collection of Tibetan vegetable drugs specimens and one Tibetan book .
- 2) One case containing Tibetan vegetable drugs specimens, negatives (I40) of photos taken during the trip to Barga and the Whingan region, with a set of prints for identification, negatives of a map of Inner Mongolia and one Tibetan medical text, as well as two volumes of a Chinese Pen-tsao.
- 3) One package containing four volumes of the Vaidurya-snon-po (a famous Tibetan medical text-book). Each text has a slip attached to it describing the contents and nature of the volume, as well as giving its title and approximate date.
- 4) One package containing the original of the map of Inner Mongolia compiled by myself from recent surveys. The scale of the map is I/500.000, and it is the largest scale map existing Mongolia existing. I am taking a photostat copy of the map into the field and shall note down our route, as well as nature of the ground. In a few days I shall forward you a list of vegetable drugs according to the rGyud-bzi, as well as a collection of interesting tables (coloured) representing the various medicinal plants used in Tibetan Materia Medica, as well as some anatomical drawings prepared by lama-doctors.

The Chinese authorities have been so far very cooperative, and we hope for good results from the forthcoming trip into the interior. I am now working on a translation of several lists of prescriptions, which contain very interesting material. Some of the herbs used in Tibetan and Mongolian Materia medica will have to be collected in the summer, for according to my lama informants the herbs growing on the Mongolian plateau have better curative properties than those collected in China Proper. Please accept our sincere thanks for your assistance and continuous interest in the activities of this Expedition.



Dear rofessor Roerich:

This is to acknowledge receipt today of your letter of February 18 enclosing expense vouchers for the months of December and January. Also, I wish to acknowledge receipt of your cable of March 19 stating that you are investigating the seeds sent on January 19. As stated in your cables, the herbarium specimens of your first shipment were received but no seeds have been received. I hope that you are successful in tracing this shipment and will give us complete information so that we may help in locating the seeds.

The preliminary report on results of botanical field work carried on last summer in Barga and the Khingan region was received. As indicated in previous correspondence, we hope that you are able to make numerous collections of valuable seeds.

The Bureau of Plant Industry has made the following request:

"Among the plants represented in the herbarium material of the first sending of the expedition to North Manchuria, No.43.I,46.I and 47.I represent Iris ventricosa Pallas. This is a species which is very rarely brought into cultivation and I wonder if you would be willing to write to Doctor Roerich to ask if they could collect or have collected next year a fairly large supply of seed of this plant. I am frank to say that this does not represent a species that will be of particular use from the point of soil erosion, although, like Iris ensatam which has already been introduced into this country many, many times, it may prove useful as forming a tussocklike plant which might shelter other and more valuable plants until they are established. It would have a secondary value to us, of course, as an ornamental ".

Decause of the apparent value of this species, I am wondering if you will be able to watch for it and comply with this request.

Dear Dr. Bressman,

I have to acknowledge receipt of your letters of March 19th, April 17th & 29th with enclosures. Please find enclosed the regular reimbursement voucher No.1012 stating the amounts which are being resubmitted, as well as the requested explanations. It was my impression that we were authorized to acquire on behalf of the Department Tibetan and Mongolian medicinal texts containing information on the medicinal use of various herbs. The List of vegetable drugs according to the rGyudbzi forwarded to you, was compiled according to the texts sent to the Department through the Legation in Peiping.

It will be impossible for us to fill out the two forms for the collection of cheques drawn on the Treasurer of the U.S., kindly forwarded by you in your letter of April 17th, as there is no one locally to witness our signatures. Windly continue to forward salary cheques to our present address as before. My cheque for the first half of February has apparently gone astray, and has not been received here.

I am very sorry for themistake in computation which occured in Bureau Voucher No. 20792. All Preaudit Difference Statements are herewith returned.

I shall instruct our coworker in Harbin to obtain a supply of seeds of Iris ventricosa Pallas. The following species are found locally, as far as I can state at present: Iris dichotoma Pallas. Iris ensata Thund. Iris Bungei Maxim., Iris tenuifolia L. The seeds from Harbin will forwarded as previously through the U.S. Consulate, and inventory list will be sent to the Department.

With regards to the request of the Bureau of Biological Survey about musk deer from Central Asia, I must state that the deer is not found in Inner Mongolia. Moschus sibiricus is to be had in the Khingan Mountains, Manchuria, as well as in the Chi-li and Shan-hsi provinces of Northern China. In Kansu musk is obtained from M. sifanisus, and in Ssu-chuan from M. chrysogaster. By far the best musk isobtained from M. moschatus found in the Kukunor highlands and throughout Tibet. From recent observation it appears that this useful animal is rapidly disappearing. To obtain a life deer

Dear Professor Roerich:

I have George Roerich's letter of May 32nd from Barun Sunit and note that you are planning to obtain seed from a large number of various grasses this season and that the prospects are very good. Also, we note that the vouchers for March and April were not forwarded because there was no one locally yo witness your signatures. In a circumstance of this kind, we suggest that you sign the vouchers with a notation stating the circumstances and forward the voucher so that we are not too far behind in submitting them for payment.

On July 3rd the following cablegram was sent to you:

"Department asks you at the earliest possible safe moment to transfer your expedition to a safe region rich in drought resistant grasses in Suiyuan - H.A. Wallace "

Also the Secretary has asked me to inform you that plans should be made for drawing the Central Asian expedition to a close not later than January 1. So far as possible by that time, you should submit to the Department all of your expense vouchers for the year 1935, and ship your seeds and specimens.

The Department will pay Professor Roerich and George Roerich's expense to northern India, where it is requested that during the late winter and sping they gather together and ship to the Department the plant seeds specimens, drug plants, etc. which they believe might be of value to the United States. You should arrive in India not later than February 1. It is understood that George Roerich is an expert on the pharmacopea of this area of India, and it would be desirable if he would send to the Department not only grass seeds of Northern India, but also seeds of drug plants. It might be that George Roerich could get into communication with the proper persons in India sometime during the next month or two in order to save the seeds and specimens which you and he might go over during the late winter and spring and then forward them to the United States with proper records.

If you are unable to complete your final and formal report of the Central Asian expedition previous to leaving Central Asia on January 1, you can delay such formal report until your arrival in northern India. I may say that such a formal report usually covers everything concerning plants and not matters of finance, and should include the following items:

The route covered, including maps and comments on important plant acreas, lists of all plants sent to the Department, recommen-

ations as to future plant explorations in this area, and particularly a good photographic record of all things of interest.

You should plan, if possible, to bring the expedition to a final and definite close about May 1.

You and George Roerich have been appointed as a Board of Survey as per the attached appointment, B.P.I.No.746, dated July 6,1935. Also you will find enclosed suggestions regarding the operation of Boards of Survey and the necessary forms for reporting your actions under this appointment. I am sure that this will be of assistance to you. I suggest that if you have any questions in regard to these matters, that you kindly advise me so that we can obtain for you the best possible information.

Sharamuren was found to be especially rich in Ephedra. The Durbit steppes abound in Agrepyrum and Stipa. According to local Mongols the best hay here in Sulyuan and around Shara-muren is yielded by Agrepyrum steppes which growth both in the steppe and on mountain alopes. Its Mengol name is khyagh. I thank you for tracing my salary check for Rebruary. So for I have received two checks in Marchy two in April and two in May. Dear Dr. Bressman:

Please find enclosed the vouchers together with statements for the period April 18th to November 30th, 1934. It will impossible for us to give a detailed list of articles purchased by Mr. Kitagawa who is at present in Japan. I recollect that he purchased a suit-case and some wearing apparel which, he stated, were indispensable. The original of the receipt for one month's salary signed by the second guard was attached to the original vouchers. It will be impossible to secure another signed receipt, for according to information received prior to our departure from Manchuria, the man was killed in action near the Mulin coal mines, where he was serving as guard (The Mulin coal mines are situated on the eastern branch of the Chinese Eastern Railway). With regards to the Rly Receipt from the Pennsylvania Railroad Co, I have to state that the only receipt in my possession had to be handed over to claim the property on arrival to Seattle. I hope that a copy can be secured from the Company. It will be impossible to furnish copies of telegrams sent between Nov. 15th-30th for all copies are at present in Peiping where they were left for safety sake.

We have to thank for your letter if June I5th enclosing the two appointemnts effective July Ist, I935. It is impossible locally to witness our signatures. Please advise whether a signature witnessed by an official of the local Mongol Autonomous Government will be acceptable. If so, we shall be glad to gorward all vouchers for I935 without delay.

Our scientific work is progressing nicely. The last few days were quite rainy, which is rather unusual for the region. So far we have gathered representative herbariums of the Kalgan area. Chakhar, Barun Sunit, Durbit and are now collecting in western Suiyuan. Samples of soils were taken in every place visited by the Expedition. During the seeding season we shall do our utmost to secure seeds of plants included in the Expedition's herbarium.

Dear Dr. Bressman,

We are in receipt of your letter of the 9th ultimo and note the future programme of our exploration on behalf of the Department. To-ay we sent you through Peiping the following cable:

" Yours minth July received shall act accordingly Roerich ".

From our previous letters and cables you know already that the Expedition was transferred to Suiyuan on June 26th. Notwithstanding insinuative and adverse newspaper reports in America, the work of the Expedition proceeds unhampered, receiving wholehearted assistance from the local Mongol and Chinese authorities. I am extremely satisfied with the work of Dr. Keng. of the Academia Sinica, Nanking, and of Mr. Yang, of the Biological Institute in Nanking. We are doing our utmost to secure a sufficient collection of seeds from a large number of forage grasses as well as of other useful plants which constitute the habitat of useful forage and drought-resisting grasses and that might be useful for sand-binding purposes. Due to rather hot and dry weather, I believe, the seeding season will be over by the middle of September, and we shall then begin the shipment of seed material and herbarium collections to the Department. We have sent the necessary instructions to India as per your letter of the 9th ult., and the seed collection will begin there at once in order to use the autumn months for collecting seeds and accompanying specimens. I believe we shall be able to transfer our exploration to northern India even before the dates indicated in your letter.

Since, I believe, there are no American boats sailing for Bombay, I am afraid we shall have to use a foreign boat on our journey to India. The Dollar Line boats require a change in Manila and stop in Colombo only. The cost of the railway journey from Colombo to northern India is prohibitive. With the fall of the Italian lira I think we can obtain a ticket for Bombay at a rather advantageous rate. We are making inquaries, and in case we find a direct US boat sailing to Bombay we shall of course use it. Please send us a short cable stating your advice.

Dear Mr. Roerich:

I have your letter of July 11th and note with interest that you are proceeding satisfactorily in the work of the expedition. In making collections of grass seeds I believe that it would be of real value to get collections of seed from various altitudes. It is well known that grasses vary greatly when grown at different altitudes and that you will more than likely be able to get different strains of the same species if the collections are made at various altitudes. Of course, we do not want to have you go to too great lengths in doing this, but believe that it should be done if possible. It might be desirable to give the altitude at which certain collections were made if the altitude is unusual.

It is extremely desirable that we bring the expense of the expedition up-to-date and I suggest that you make out and forward expense vouchers for each month as soon as the month is ended wherever this is practicable. Right now we are several months behind and, as I formerly indicated, it is not necessary to have your signature witnessed if you will state the conditions under which the voucher is made and make an exact statement that no witnesses are available. Kindly give these fiscal matters your attention.

As per instructions received from the Department we have sent by ocean freight our collections of seeds and herbarium addressed care of J.S.Roberts, U.S.Despatch Agent, Room 5, Ferry Post Office, San Francisce. The shipment consists of four large cases (two cases with seeds, and two with her parium specimens and soil samples). I am enclosing a list of seed material collected in Inner Mongolia. NNo. 123, 124, 125 marked Oryzopsis in the list was found to be Timouria Sapozhnikovi, discovered in 1915 in the Tien Shan. The grass has not been previously known to exist in Inner Mongolia. The field labels covering the systematic herbarium have been sent to your name by egistered parcel past. Each specimen has a tag with number corresponding to the numbers on the labels. Under separate cover I am forwarding a list of plants collected by Dr. Mozlev, of the "ientsin Museum, in Chakhar, I have received information from Harbin that our collector in North Manchurie has secured a considerable supply of Agropyron pseudo-agropyron seeds which will be sent direct from Harbin. On reaching India I areas proceed with the preparation of the detailed scientific report on our exploration in Eastern and Inner Mengolia, and have already began work on a map showing the different vegetation areas in Inner Mongolia. This map will be based on entirely new material collected during the present Expedition. A complete photographic record will be send with the Report.

The Expedition's fire-arms consisting of six Spring-field rifles and four Automatic pistels have been handed over to the Legation authorities as per your cable instructions. The two field-glasses and canteens have been sent to the Department by parcel post. Tents will be sold, as desired.

We are leaving Peiping to-day for Shanghai.
