- I) one case containing seeds and botanical specimens (vegetable drugs specimens).
- 2) one case containing botanical specimens; two packages of negatives; one package containing negatives of map of Inner Mongolia; and a Tibetan-Chinese list of Materia Medica.
- 3) one package containing four volumes of Tibetan medical texts.
- 4) one package containing the original of a map of Inner Mongolia.
- 5) One package with botanical drawings.

Camp Temur-Khada, August 19th, 1935. H.E. Nelson T. Johnson, American Minister. Peiping. Your Excellency, Fellowing receipt of your radio of August 16th, we have sent to-day the enclosed reply which, we hope, has safely reached you. The Expedition's field work is proceeding satisfactorily. The seeding season will be over in a few weeks and we shall then return to Peiping to arrange for the despatch of the collections. We are at present working in the vicinity of Pai-ling miae, one day's motor journey from the railroad at Kueihua. Our address remains c/o Rev. Gunzell, Pai-ling Miao, Sui-yuan.
