Please give us the correct way to address you so that we have it correctly in our addresse book and also this is most important for the Memorandum of the Society we are now forming for Registration which we shall send to you. relating to Svetoslav's Exhibition in the U.S.S.R. reached you safely. Just now a friend sent us a wonderful packet containing about 20 postcards printed at The Hermitage of Svetoslav's paintings each different and quite nicely reproduced in colour with a very fine forward. We are expecting a parcel of these from the Hermitage as complimentary copies and we shall send you a few copies as soon as we receive them. A hundred thousand of these have been printed and we hear that practically all have been sold out.

We sent a Wire also to Raya after hearing this so that she may send us some.

You will be glad to hear that the Stupa wall has been now completed and some friends of ours with our representative there will plan the garden for which we have sent them extra money.
