
My dear Javika :

There is ^{also}, I am given to understand, some difficulty in its broadcast from Delhi on the 12th of October. However, we are broadcasting it in External Services on the 10th of October as already intimated to you by me.

A tape recording of the talk along with the script has already been forwarded to Mrs. Sina Fosdick, Vice-President of the Nicholas Roerich Museum at New York.

My dear Devika:

You will live for ever. Just when I was saying to myself - I wonder why Devika hasn't written, your letter arrived. Another one came today. Thanks a million.

I have just been to see your friend Vivek. He seemed quite cheerful and told me that he was feeling much better. He hopes to leave the Nursing Home soon. He said that his article on Dr. Roerich will be appearing in 10 English dailies and some Indian Language papers on the 4th of October. He wants you to mail him immediately 10 copies of Dr. Roerich's photograph with Pandit Nehru. He would like ten copies of the same photograph and not difference ones.

I have spoken to Miss Masani. She said she was asking us to send a dubbing of ~~the~~ Svetoslav's recording to New York. (It is External Services who do it.) I shall see that it is despatched as soon as I can get hold of a copy. (That Nair never sent me one.) It won't cost you anything. We shall send it by diplomatic bag.

My dear Devika:

I received your letter of the 1st just this morning. Either our letters have crossed, or mine to you has gone astray, because I wrote to you days ago to tell you that the tape-recording of Svetoslav's talk had already been mailed to New York. It should have been there by now.

I am sorry about the mess the Akashvani people have made. I don't know who this Mr. Pandey is. In any case nothing can be done now. So far as India Calling is concerned, you should have no worry. I see the proofs. But as we work several months in advance, I doubt if we shall be able to publish the talk before the January issue. The November and December ones are already in print. And we don't normally publish photographs of talkers. So, what I would like you to do is, to send

me a photograph of a portrait of Dr. Roerich done by Svetoslav. And also a couple of photographs of his Himalayan paintings. Those could be printed to illustrate the talk.

About printing the talk in Akashvani with a proper photograph, I suggest that you ask Nayar to write to the Editor of the Akashvani. My saying anything to anybody will not be appreciated. You know, what this place is like.

Yes, Nayar wrote and said that he had seen you and also told me where to get a copy of the recording. I had already got it, and despatched it to New York!

I told you in my last letter that for some reason Delhi is not broadcasting the talk on the 12th, as they had originally said they were going to. In any case, we are putting it on the 10th. So people abroad will be able to listen to it.

I apologise for not writing all this while. As a matter of fact, the last letter I wrote to anyone was to you. After that, first, I came down with an attack of diarrhoea and high fever and, after that, I have been laid up in bed with slow temperature. The doctors could not diagnose the cause of illness. Yesterday, however, I have been told that I am suffering from a mild attack of pneumonia and the doctors think that the temperature should come down within the next 3 or 4 days. I will not go to office for another fortnight.

I received the photographs you sent me. Thank you very much. I am afraid, however, there is some snag about getting Svetoslav's talk published in India Calling. However, no final decision has yet been taken. It will be decided after I go back to office. I still hope it will be possible to get it done.

There is no other news. I hope your friend, whom I went to see at the Willingdon Nursing Home, has fully recovered now.


