My dear Colonel Mahon,

Just received your letter of yesterday with the enclosure. Many many thanks. Yes, we shall send the car up definitely on Wednesday next. Aug.7th beyand Baran, a mile or more as far as it can go. Me will leave Patlikuhl at 8 am. I shall be at the Bridge at 9.30 and will write a note to Mr.McCullagh asking him to be at Katrain PO at 9.45. I understand the road to Kulu is also not in perfect condition so whatever spare time waxhawa we shall have, will probably be needed to get to Kulu in time. Yesterday there was no mail from Kulu at all . let's hope it won't rain too badly, so that we can get through. It would be useless to pull horses behind us, for then they would have to motor at their pace and would never get in time. To send them shead would not be possible for one cannot guess where and how many slides there might be and they may occur overnight. But perhaps to take two shovels and an extra cooly would not be bad and the latter and the driver might then clear reasonable obstacles. I will anyhow take down the shovels.

Since they have already dragged the case for four years, in case they are not satisfied with Prof.de Roerich's previous authorization, they may then as well put it off till the spring, when Prof. de Roerich will probably back again. Well, we'll just have to try our best. I believe the letter to the pleader is fully OK, for as far as we are concerned the main thing was to keep the pleader informed of it.

Mr.Sv.Roerich thanks you very much for your letter of the 4th and so do I for your letter to me.
