Dear Prof. Roerich,

in the absence of Prof. Tucci I have the pleasure of answering your kind letter of September 24, 1955; first of all I feel we must apologize for the trouble we are giving you on the matter of the appointment of a suitable Lama, while expressing our sincere appreciation of your kind efforts directed towards a timely and satisfactory solution.

Concerning the first candidate, Chhimed Rigdzin Lama, he has written raising some points on the adequateness of his salary, and in order to overcome any hesitation on his part, we have made further suggestions. His family has been offered a monthly allowance of RS. 150, for their accomodation in India, above his own salary of 60.000 here, which is a satisfactory arrangement, which works well for other collaborators of the Institute. It is to be hoped we may get a speedy and definite answer, as time is always pressing.

If, in spite of our urgency, Rigdzin Lama is not able to reach here shortly, we would be obliged for gattting some more pertinent news about the second person mentioned in your letter, i.e. Shri Rigdzin Lhundub; whether he is single or married, whether he may leave soon, and above all whether he is well qualified for the sort of work he would be called to perform at the Institute. I hope you may get the opportunity of meeting Prof. Tucci, who is actually in India, and will be entering Nepal in a few days, as I well know how keenly he wishes to see you. Please accept our renewed thanks for your kindness, and constant help, to which I join my kindest regards and good wishes.
