In September 1934 I sent a check for \$2000.00 towards Professor Roerich's trip. This check was made out to him. I wonder whether that ever reached him. I believe Miss Campbell sent the same amount. I have no receipts except for a note for \$5,000.00 which I loaned to Mr. Horch towards paying taxes or the bondholders, but I am not sure. It seems that the Horch lawyers are doing their utmost to tire out anyone who has any legal dealings with Horch. My suit is not progressing any better than the Lichtmann's or yours. However, I do not despair and I think we will catch Horch somehow, because he has not denied that he owes me the money. The reason I am pushing this so far, is because if this comes out in the open, I think it will help your case materially, at least that is my hope.

I have been away to St.Louis for a Convention of the Women's International League for Peace and spent six very interesting days there. I drove out and back, and had a beautiful drive across the mountains, over very good roads. St.Louis people are so very hospitable and when I was not attending sessions, I was very pleasantly entertained at people's homes.
