

Our dear Briend,

We have received from Sina a copy of your letter to Ernst and it was a great joy for us to see clearly and impressively you summarized the whole situation. We presume that Ernst felt ashamed reading your frank judgment. When one compares his reply to you, it sounds so evasive and flat and it is clear that he has nothing to say for his justification. Indeed how could their firm conduct a case against their own clients?!! It seems that in the hands of our lawyer there is so much of striking facts and evidences that it would be strange if he does not know how to use them. But still, from the last letters we learned that in the Tax hearing he succeeded entering into the records some useful points, which thus remain in the history of this unprecedented case. All the lies which Horch uttered indeed transgress human limits.

We would like that you should read over Dr.Harshe's statement quoted on page 170 of my "Fiery Stronghold".

He then said that any harm inflicted to our institutions would be a 'national calamity', and further Dr.Brinton spoke about the invasion of barbarians. This whole passage

very tragically now applies to the vandalism of the apostates. When we re-read these pages we found that we would have nothing to add now. - Mr. Plaut recently mentioned that in the Appellate Court he will be 'at home' - let this be so as he has all the possibilities and five judges will not be as unjust as Frankenthaler. Anyhow before Plaut there are further court instances as finally Truth and Justice must be found somewhere. Our dear Friend, dear Mrs Sutro,

From every letter of Mrs Sina Lichtmann we hear how valiantly and heroically you defend Justice. As a true American citizen you stood up against vandalism - it is by such voices as yours that public opinion is forged. We were also deeply touched to hear that you are now Chairman of the R M. Committee. This group of defenders of the Museum is now lead by your inspiring enthusiasm. Indeed the vandalism committee by the apostates is unheard, Is it possible to annihilate a public museum which existed for 15 years, by the ill-will of a single criminal?!! When in 1932 there was danger for the museum at the time of the receiver, the late Dr. Robert Harshe defined this as a national calamity. At that time a well attended public meeting of protest was held and new when the actual vandalism has been committed one cannot forget the words of Dr. Harshe, this indisputable authority on art. On June 7th the apostates have a meeting of the Trustees of Roerich Museum; no doubt they now scheme some fibal and fatal move and should they be successful in their grim attempt, then the whole institution will be destroyed. We were shocked to hear that the Attorney General did not sonsider as criminal the fact that the public collection for the institutions new turn out to be misappropriated by Horch for his personal ends. In what an ugly position are now all donors, honorary advisors and coworkers, who never dreamt that they were supporting a private affair of H.!! Is it possible that when the case still goes into the Court of Appeal at the same time a crass vandalism is committed against the Museum?

H.acts as if he can do in America what he likes. He throws 1000 paintings into some dungeon, apparently to this fate are subjected also the hundred paintings from the IVth floor. He grabs the whole property of Svetoslav and all manuscripts of Mme Roerich, representing decades of meticulous work: he steals all shares of the Truutees, throws them into the street and demands from me sums, which you know were for the expedition. As Sina rightly wrote, where is that Zola who would powerfully defend Justice. It does not even seem to arouse the indignation that H.operates with faked papers. One can hardly imagine that in court there would be accepted a home brewed copy of a "document" which never existed. Now this fact is already known as one of the judges openly stated that "this is the case W.kept botharing me about".

Our dear, dear Friend, Mrs Sutro.

I am writing you to express again my admiration at your indignation against the vandalism done by the apostates in the museum and also our deep gratitude for the active defense of the right cause. Your indignation against this vansalism will remain recorded not only in our hearts but also on the pages of the history of Culture, where will be inscribed the monstrous fact of the destruction by one man of a museum which had been presented to the Nation, - of a museum which contained a unique panorama of Central Asia and the results of the labour for over a quarter of a century of one of the best contemporary artists.

You know with what love Prof. Roerich gave to America his brilliant constructive ideas and his masterpieces. You know how highly Professor Roerich always spoke and wrote about America, therefore your indignation at the present looting, committed by the apostates in that country, is indeed fully justified. Sina writes that she receives many letters and telephone calls asking about the fate of the museum, Many even offer their services to help the present situation. But of course all these separated voices and single protests can help very little. An organizer is needed, who could gather and direct all these efforts to difinite actions. But, helas, we do not know of such a person. Of course if all who wish to help would gather together and would decide (even if in small groups) to visit and present their protests against the vandalism to all officials and representatives of the country, this measure would be already of considerable help. for after all it could arouse public opinion and thus perhaps influence the judges to make the right decision. We would like to see the indignation of public opinion not only for the sake of our case, but for the sake of America. We witness a most serious time, when human dignity and all moral Councations upon which is based the welfare of the people are trampled upon and there reigns but the right of usurpation supported by abyonets or gold. I am surprized at the negligence of the judges who never were interested to acquaint themselves thoroughly with the moral and public standing of the two main figures of this case. If the judges

will base themselves exclusively upon forcibly extracted under various pretences papers and home-brewed "documents", fabricated by our former feduciary, and will absolutely ignore the entire moral side of the case, then any gangster will of course be justified. It seems to me that judges should be first of all great psychologists and guardians of morals, otherwise the court will become a carricature, and the judges - hirelings of those who are temporarily in power. Is it possible that the voice of judge O'Malley will remain a voice in the wilderness?

We know that it is thanks to you that such a renown jurist as Seabury agreed not only to act as advisor in our case, but even to speak personally before the Board of Regents in Albany and for such a comparatively small remuneration. Of course I am sure that his participation means salvation. As Major Stokes rightly said, the participation of such a lawyer guarantees hundred per cent success. But unfortunately from Sina's last letters we understand that Plaut, who demanded and insisted upon the invitation of a big lawyer for this last appeal, again raises some difficulties. Since long we have written to our co-workers that we do not trust Plaut and know that he will lose the case. Every time when Plaut wished to abandon the case because he was not paid in time, or he had doubts whether he will be paid altogether, we advised our coworkers to make use of his intention and to part with him, but unfortunately usually some circumstances intervened. I think with sorrow that even now when we approach the last court from where we may expect justice, the brilliant possibility of Seabury's participation may be lost. May we avoid such misfortune!

We are so happy that you took upon yourself the chairmanship of the R.Museum Committee. Your untiring energy will
greatly help matters. The new lawyer Smyth, as you no doubt
know, has expressed several useful considerations and it is
especially gratifying to know that he acknowledges that the
declaration of 1929 signed by all Trustees about the gift
of the paintings to the Nation, has a great moral significance
and defines the status of the paintings, as this resolution of
all the Trustees has never been cancelled. We were very happy
to hear after all these years of litigation this lawyer's
assertion about the significance of moral obligations. The
entire case should be considered exactly from its moral aspect. I have always considered that Horch should sued by all
co-workers and conors simultaneously and jointly, then the
picture of his long ago premeditated plan of robbery and usur-

pation would appear clearly in all its monstrosity. Indeed it is necessary that all judges would be acquainted with a 1 1 his criminal offences. When taken in their totality, these offen ces show a congenital criminal. You know, dear Mrs Sutro, that you yourself, all our friends and coworkers donated and gave all their labour only for the benefit of public institutions and not for Horch's personal affairs. All of us worked only for the growth of these public institutions. And as we see now enermous possibilities were systematically destroyed by Horch. He became afraid of the growth of these institutions. He understanddthat after some years it would be impossible for him to execute his plan of usurpation, Wishing by a single stroke to get all into his hands, the fool has himself cut off his best possi ilities. In a few years from now, he will be forced to see his folly, because his bosses will be great. The new lawyer Smyth's opinion that the case should be protracted because Horch himself will tighten the rope around his neck, is quite true.

My dear Mrs Sutro, I do not wish to burden you with too long a letter, but I would like so much that you should know how grateful we are to you for all your help and support and how we cherish your rightful indignation. A great thinker said: "The indignation against injustice is the healing of the blind ones". Verily there are many blind ones and few healers, therefore my heart greets in you such a healer. A flaming heart is the most precious treasure - such a heart is a real life-giver. Sina writes so beautifully about the help and support which you extend and every such line resounds in our hearts.

We appreciated deeply your September letter. Indeed is sounds tragic that also in your case you have to expect that politics will upset justice. If even in such a simple obvious case as yours justice cannot be expected, then words fail altogether. We have just looked over the American Art Annual for 1930, officially published by the American Federation of Art. In it it is stated: "Roerich Museum - permanent Collection of 1000 piantings". Thus from year to year people were reading this official statement, and of course they had no reason to distrust the American Federation of Art. Yet it appears that the public was misled with false information, for a permanent collection does not appear to exist. And all true facts are trampled upon by Horon with his faked paper, false information and fabricated testimony. We cabled that our lawyer should ask the Court of Appeals . to grant a revision of the whole case because we both have never been asked for our testimony, which we want to give here. Since I have already in another matter given a deposition here and Mme Roerich also had papers for a deposition sent to Naggar, this precendent shows that such a deposition can be given here, and when the plaintiffs want to make a most important statement, the Court cannot deny this demand, or it would be a premeditated injustice on the part of the court.

I cannot refrain from repeating how happy we are that you are now the Chairman of the R.M. Committee. If the vandals and aggressors took possession of the museum premises. this not mean that the actual idea of the museum no longer exists. Japanese aggressors have taken the capital of China and vet China will exist. I do not know who is Vice-Chairman of this Committee, but since there can be several, we consider Sina would be the best help to you. In her last letter she wrote that you visited the new Academy and liked it. We are also most happy that you are Patron of this hearth of art & culture. Let us hope that now when there are no traitors inside the organization, that this seed will gradually grow into a struck oak. - How do you like FLAMMA - and did you receive the monograph by Conlan? - everybody praises them. It is quite remarkable how on cooperative bases with practically no initial funds except a donation from Fosdicks, such a useful world quarterly came into being.
