Dear Mr Roerich,

On receipt of your telegram yesterday morning, I sent off a telegram saying "Booked to reach Bombay 3rd June weather permitting letter follows regards Bhavnani." I am writing to say that we have booked to go by plane to Delhi on Sunday 1st June morning and to leave Delhi by train on the 2nd, reaching Bombay either on the 3rd morning or 3rd afternoon depending on whether we get the booking on the morning or afternoon train from Delhi - But as the weather is very uncertain this year, sometimes planes are delayed - and so I said "weather permitting. In any case we should be definitely be in Bombay not later than the 5th June -

Now regarding the film particulars - I have three shots of your father, two by himself + one with Makshi - The film was shot in 16 mm Kodachrome in 1945, that is 13 years ago - These shots of your father are quite good and in fact the whole film is in quite good condition, but naturally colour fades and the quality would not be as good as a film freshly shot. Of the Kulu material therefore, the shots of your father being historical material and very valuable could be used in a new film and would be alright - but all the other shots of Kulu itself + the paintings would have to be done again. Because in a film a few shots that are not perfect quality may be put in and would not appear bad at all, but this the entire film if not up to quality would not be good - I therefore suggest that a new film on Kulu, the house, the paintings etc. be done either in 16 mm Kodachrome

be blown up to standard size, or it be done in 35 mm² standard size. The photo of your father could then be carefully incorporated either in 16 mm if the new film is in 16 mm Kodachrome or be blown up carefully and used in the 35 mm film.

I had promised Mr Baikar that when I get back to Bombay I would write to him a detailed scheme for the film. But if you would prefer that your brother handles the matter, do please let me know. We can either discuss this in Bombay when I return + if you are still there, or you can write to me to Bombay. I shall not write to Mr Baikar till I have your views.

I am feeling much better and the weather + beautiful surroundings have benefitted me greatly - Trust this

finds you + Devika in the best of health with warmest greetings and love from Enakshi + myself to you + Devika.
