The consignment mentioned above was imported by you without an Import License in contravention of the Import Trade Control regulation and you have thereby committed an offense attracting the provisions of Section 167 (8) of the Sea Customs Act. The goods were, however, allowed to be removed out of Customs control on your executing a Letter of Guarantee undertaking to produce within one year an import license issued by the Import Trade Control authorities. No such license has yet been produced by you, although the period allowed for its production under the Letter of Guarantee has expired.

2. The failure to produce the requisite import license within the stipulated time has rendered you liable to penal action under Section 167/(8) of the Sea Customs Act. I, therefore call upon you to show cause within ten days hereof, why action should not be taken against you under the aforesaid Section. In case you wish to be heard in person, you should state so and see the undersigned on any working day during the usual interview hours or by previous appointment within the period of 10 days aforesaid.

3. If your explanation is not received in this office within the time limit specified above, the case will be adjudicated.
