Mrs. Katherine Campbell B rookfield, Conn. Dear Katherine: Before leaving on a month trip West, I want to send you my greetings and my hope that you have been well. I am sorry we did not have the opportunity of seeing each other last winter as I had looked forward to hearing that you would be in the city and perhaps reach me. I know, however, how many commitments all of us have, so that I can well understand how occupied you were. I am writing again really about the storage. I am intent on liquidating this incumbrance immediately on my ret urn. After having paid many hundred dollars for storage, personally, I still find that there is a remaining obligation of \$300.00. Since most of this storage comprises papers belonging to the Roerich Museum Press, I feel that at least a great portion of this outstanding indebtedness should be paid from the balance of the assets of the Press - in other words the books. As you know, all the convertible assets of the Press were removed in accordance with out mutual decision to Connecticut, and I do not know just what status they are in at present. If you or Inge find it difficult to come to the city to see me personally on my return so that we can frankly discuss this situation, I would appreciate it if you would let me know the situation of the Press Editions so that we could mutually decide how these could be converted into assets to cover at least partially the outstanding indebtednesses of the Press. I shall return about the 21st of Stptember and hope that I may have some word from you at my arrival. Setting aside these tedious details from a past epoch, let me turn to something more pleasant: that of sending you and Inge my always sincere affection. I assure you that the one pleasant spot in the recollection of an indidious episode remains my feeling for you both. As ever, Frances R. I have been able to get one of the Book Dealers to go to Danbury and see the books toward the purpose of buying them. If you let me know when it will be convenient for you to have him come, I will so inform him.

Certainly, I did not wish this matter to run into the New Year. prefer having it settled amicably before the New Year begins and before you go for your operation. The impact of a decade is long enough it seems to me, for this matter. Therefore, if yous till prefer to finish the matter on your original offer of \$150 with the books remaining your prope rty, I will agree. I want to assure you that I am perfectly aware of your personal disinterested attitude in all the matters that pertain to the Museum. I have said it before and I repeat it now. In regard to myself and the matters of the Press, I merely wish to mention, in passing, what I had not previously mentioned: namely, that I personally paid out of my own savings for some of the complete editions of the Press, notably the Flame in Chalice and other of Professor Roerich's writings. This is not to mention the years of unpaid salary. As you know when this matter was over I was left not only without the fruits of 15 years of work but in debt as well. However, I should like this new decade to begin without bitterness and, I hope, friendship on our sides. I preserve for you and Inge a very deep esteem and affection.
