Dear Sina:

We are aware that we have not as yet answered your kind letter of October 1st and now we receive your note of October 19th. Many thanks.

First of all thank you for your check of \$18.00 for the Romeike Clipping bureau. I hope that you have found a Clipping Office which is more on its toes.

The books (111 Foundation of Buddhism) actually left on September 18th, of which Madame Roerich has been informed. There had been several delays as there are so many specifications to follow. No cardboard boxes were acceptable nor weak wooden boxes. Also Danbury had to get the information on it from New York which would make the books wait longer. But the actual date of departure is September 18th, all books packed in one box of wood and tin lined. Automatically the American Express Co. insures these books to arrive safely at destination in New Delhi. Now comes the shock, the price of the expressage and clearing of the books over there was \$56.00.

I shall send you the requested 6 copies of "Realm of Light" by the same mail and hope that from now on we can promise you quicker answers to your letters.
