Gentlemen:

We have read in the Journal of the Association of American Medical Colleges a notice regarding the fund established by Egbert C. Fuller for the alleviation of suffering from disease and especially for the control of cancer. We wish to bring to your attention the work of the Himalayan Research Institute in this field.

Founded by Professor Nicholas de Roerich, and under the direction of Dr. George de Roerich, the Institute includes among its corresponding advisors, such eminent scientists as Dr. Albert Einstein, Professor A. Millikan and others. The various departments are headed by specialists in their own field.

Research in cancer is one of the most vital phases of the Institute's program. Situated in the Western Himakayas, the Institute has access to a field that seems uniquely suited to this purpose, both because of the fact that there is no cancer in this district, and because of the importance of the native pharmacopoeia, which it is believed will yield invaluable remedies. It is significant that Professor N. A. Zavadsky of the Pasteur Institute, a noted cancer specialist and radiologist, who lectured under the auspices of the Himalayan Research Institute in New York last November, has expressed herself as most keenly interested in the possibilities of cancer research in this region.

During the past year, extensive work has been done in the Departments of Medicine as well as other sciences. Representative collections of Himalayan flora and fauna have been sent to various European and American institutions. Valuable collections of native pharmacopoeia have been made, and the first sets of medicinal extracts have been forwarded to Dr. Felix Lukin, of Riga, and to Harvard University, for further experimentation. A bio-chemical laboratory will be erected this coming Fall for intensive research in this department.

Having just returned from the Himalayan Research Institute at Naggar, Kulu, India, I should like to answer you on the points you brought up in regard to our cancer research work. You seem to be unaware of our program of research in the Bio-chemical and Cancer Research Departments, in presuming that we follow the same old trend of research by vivisection, or attempt to discover a cure for cancer by means of experimentation upon animals. Our Research Institute pursues its investigations to discover a cure for cancer through research with the thousands of plants and herbs which we have collected on the uplands of Western Tibet, Ladak, Kangra District, Rampur Bashahr, Kulu Valley and the Plains of Punjab, etc. All these plants were collected at various altitudes, ranging from the plains to the Tibetan uplands of 18,000 ft. altitude. We have a permanent base in the Himalayas, at Naggar, India, with summer headquarters in Western Tibet, which gives us the unique possibility of investigating the curative powers of the plants on the place. My dear Mrs. McElroy:

In response to your inquiry, I hasten to write you that the Mimalayan Research Institute is not at present in a position to give any direct advice on cancer cases. The laboratories for Biochemical and Cancer Research are now under construction at the Headquarters of the Institute in India, although extensive collections of medicinal herbs and plants, as well as Tibetan pharmacological treatises, are already being studied at the Emergency Laboratory of the Institute. The Tibetan pharmacopoeia is known to have in its possession remedies for both cancer and tuberculosis which have been used with success. It is the earnest hope of the Institute that it will find in its research, effective remedies for this desease.

There are two splendid organizations here in New York, now working for the same aim of battling the ravages of cancer: the American Society for the Control of Cancer, Inc., 25 West 43rd Street, New York City; and the Columbia University Institute of Cancer Research, 1145 Amsterdam Avenue, New York.
