Upon learning that the mirror had been damaged I immediately took the matter up with the Hudson Forwarding Company and received the enclosed letter.

I agree perfectly with the Hudson Company - that any damage incurred was due to careless handling at Bomday. The mirror was tightly packed here in a separate box, facing a soft pad and wrapped with paper to prevent its being shaken.

The shipment was insured, but I learned today that the insurance was only against loss or pilfering and does not cover breakage or damage.

If the mirror is too badly damaged for use, please advise me immediately so another can be sent. If the scratches are deep, it is doubtful if they can be ground out without throwing the mirror out of focus.

I sincerely hope that damage was not serious and that by the time you receive this that the telescope is mounted.
